

### Covid-19 (Coronavirus) guidelines

This document does not intend to contradict or take away from anything in the application form, code of conduct form, schedule form, indemnification agreement form, assumption of the risk agreement form, and waiver of liability agreement form. If there is a conflict in the documentation, then the application form, code of conduct form, schedule form, indemnification agreement form, assumption of the risk agreement form, and waiver of liability agreement form will control. This document is subject to change based upon the changing circumstances of the virus and vaccines, as well as treatments.

- As stated in the code of conduct all policies and rules and procedures must be followed in each country that we are in, as well as any common carrier like a taxi, bus, or airplane. This includes but is not limited to the wearing of a mask, in public places, as well as social distancing.
- While traveling, you might be required to wear a mask, in all public places, especially on subways, taxis, buses, and shuttles.
- All of our current shuttle services are following the laws of the country, and they may have limited seating on each shuttle, so participants can social distance.
- All participants will be required, under the current circumstances, to take a Covid 19 test two weeks prior to travel. Participants will have to provide evidence that they are Covid 19 free, based on that test.
- In the event that a participant has Covid 19 two weeks prior to travel, then the participant will not be allowed to continue on the trip. No refund from the trip would be provided, because all of the expenses of the trip would have already been paid in full to all the vendors. It is highly recommended that every participant purchases *a trip cancellation policy*, if you are concerned about this possibility. Philosophy in Greece LLC. does provide travel insurance, which includes medical and dental care, emergency evacuation, and lost luggage. However, *trip cancellation insurance is not covered by the insurance policy*.
- In the event that a participant contracts Covid 19 while traveling, then the participant must follow all the laws and regulations of the country including but not limited to self-quarantine. This might include the participant changing from a multiple occupancy room to a single occupancy room. Thus, additional cost may be incurred by the participant, if the participant is required to self-quarantine.
- As stated in the indemnification form, assumption of the risk, and waiver of liability form, all participants must follow the advice of any doctor in current country, or in the United States, as well as the directions of the program representatives.
- If any participant were to show signs of illness that is Covid 19 related or unrelated, then the participant is obligated to inform the program leaders immediately, and without hesitation.
- All other safety rules and regulations that have been published by the CDC, Airlines carrier, shuttle carrier, the World Health Organization, the program guidelines and policies, as well as any other reasonable methods to avoid Covid 19 should be followed at all times. Failure to comply with all safe practices could result in removal from the program and returned to the United States at the participants expense.
