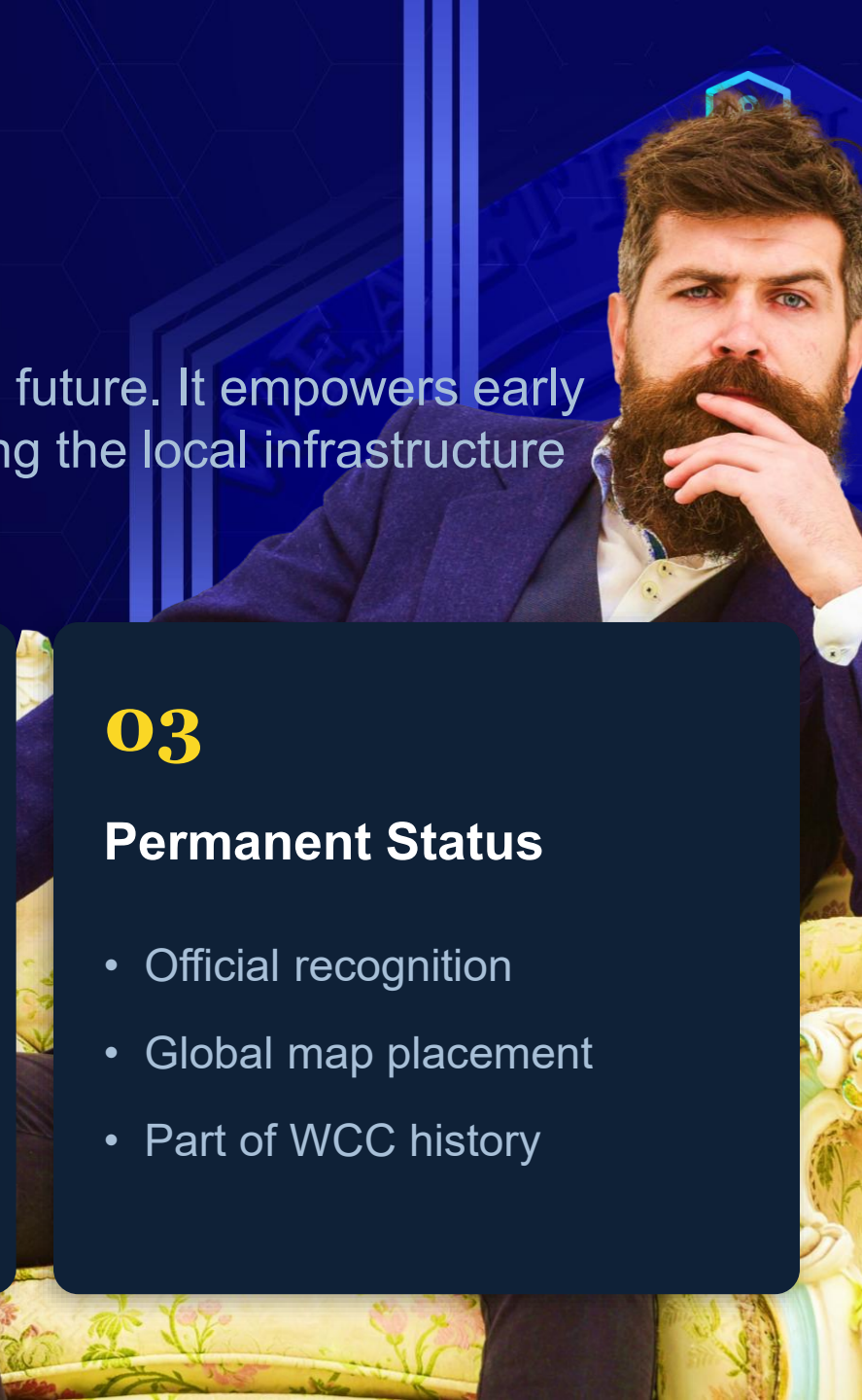

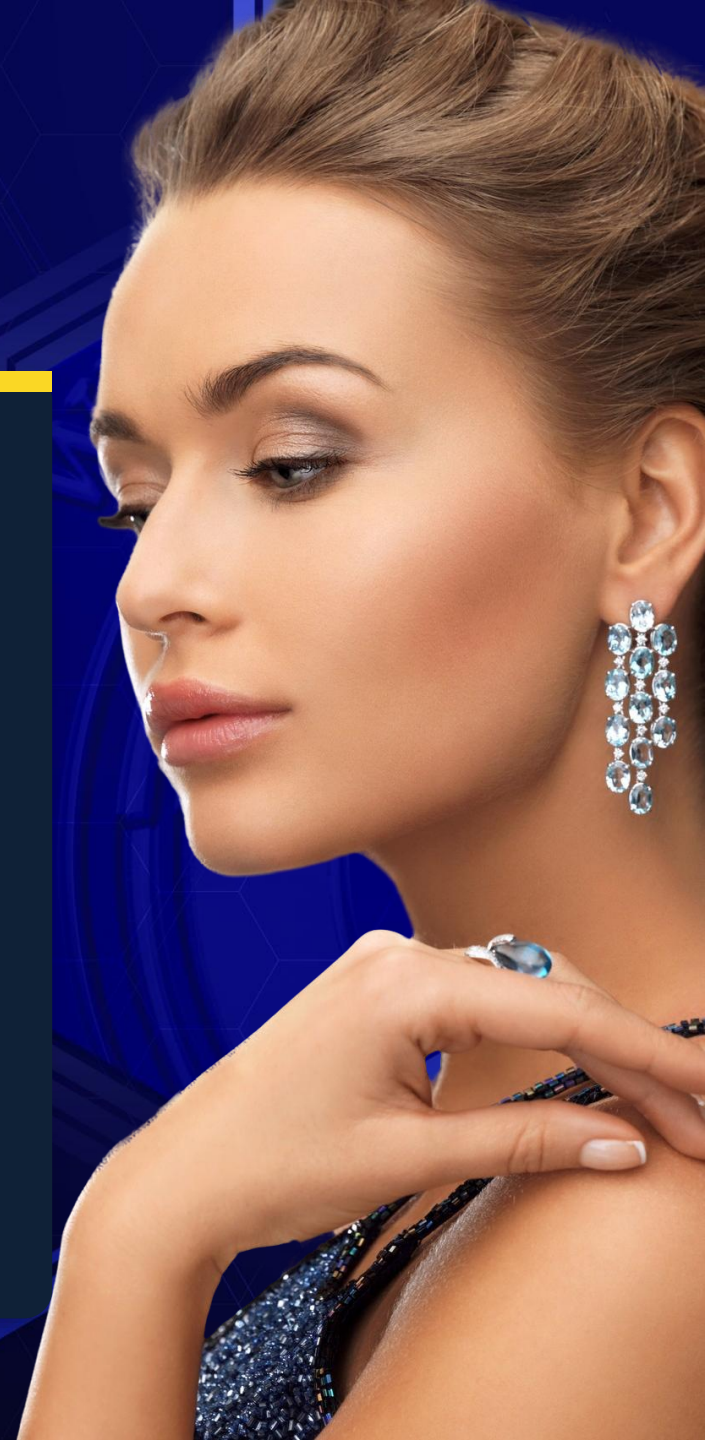
What you receive on day one

- ▶ Priority access to events & testnet

REVENUE SHARE

What you earn as the project scales

- ▶ Global Participation: 0.15% – 1%
- ▶ Own Nation Participation: 0.4% – 5%
- ▶ Partnerships Participation: 1% – 5%
- ▶ Real Estate Deals: 5% of deals you close
- ▶ Permanent positioning in the ecosystem



OPERATIVE VS EXECUTIVE

Two paths. Same mission. Different focus.

OPERATIVE

Hands-on execution

- ▶ Local events & community activation
- ▶ Real-estate deal flow
- ▶ Day-to-day leadership of the national campaign
- ▶ Ideal for operators, networkers and builders who want to run the machine

EXECUTIVE (VIP)

Strategic & high-level influence

- ▶ Direct access to the Global Leadership Board
- ▶ Focus on partnerships, sponsorships and capital introduction
- ▶ Country-level strategy and oversight
- ▶ Ideal for high-net-worth individuals, established entrepreneurs and influencers who prefer leverage over daily operations

NATIONAL FOUNDING PARTNER (\$25K)

Only 1 per country

- 5,000,000 WCC (value \$600,000)
- 25 WCCRE Tokens (value \$25,000)
- Own Nation 5% of capital raised
- Global ICO 1% of capital raised**
- 2-5% on all direct closings (real estate + partnerships)



SCARCITY IS REAL

Top positions lock forever once filled. We begin with only 10 countries. The leaders who step forward first open the door for their entire nation to be in WCC's first global wave.



Ideal Team Structure Per Country

The winning formula for a strong national launch:

- **1 × T5 – National Founding Partner**
Country founder. Full strategic ownership + highest economics.
- **3 × T4 – National Ambassador Partners —**
Core leadership circle. Execute strategy, drive major deals and visibility.
- **10 × T3 – National Partners —**
Strategic reference points. Expand reach, close deals, support events and activation.



LEGAL FRAMEWORK

- 🌐 **Official Certificate of Appointment** issued to every initial Nations Program member
- 🌐 **Pre-ICO formal written agreement** detailing all benefits, responsibilities and percentages
- 🌐 **Monthly account reports** by nation and globally
- 🌐 **Full ICO reconciliation report** to finalize all payment effects
- 🌐 **All payments executed strictly according to the signed agreement and fully**



EXECUTION

How the Nations Program Works

1

You Step Forward

Choose your tier and claim your role in your country.

Country Activates

Once a strong team forms, the nation enters the first wave of 10.

3

Budget Allocated

Corporate assigns a dedicated growth budget based on team strength.

4

You Co-Lead

Founding & Ambassador Partners help direct strategy, events, ads and deals.

5

Public ICO Launch

Local campaigns run in parallel with the global Public ICO.
