PRESENTATION AND DISCUSSION – LOCAL LAND SURVEYOR MARK KRAUSE
Vice-Chair Conroy introduced local Land Surveyor Mark Krause. Mr. Krause has worked in Burnett County since 1980 as a surveyor. He was an assistant for the first few years at Wagner Surveying in Webster and has been licensed since 1984. Mr. Krause has been owner of Wagner Surveying since 1989. Additionally Mr. Krause has worked in all phases of development for many years and had his soil tester license for over 20 years. Mr. Krause questioned the work group members on what they would like to talk about or what information they are looking for from him. Discussion, questions and answers ensued on the following subject matter; county zoning, development of campgrounds, where campgrounds should/would be best located within the county, Act 67 changes that have affected land use, development of a consistent process and criteria to be met when approving or denying Campground Conditional Use Permits (CUPs), the history and evolution of a campground, previous and current campground issues, taxation and lack of, arguable and irrelevant information for decision making, categories of campgrounds and density guidelines, tourist dollars and county revenue. The work group members thanked Mr. Krause for attending and providing information. They will continue to meet with others over the next few weeks at meetings to gather as much information on all aspects pertaining to Campground CUPs as they can. This will allow the work group to present suggested updated guidelines and ordinance changes for Burnett County to work with.
