**PRESENTATION AND DISCUSSION – PUBLIC REPRESENTATIVE DON HAMILTON** Vice-Chair Conroy introduced Mr. Hamilton as a representative of public persons interested in recent years growing number of campground CUP applications. Mr. Hamilton frequently participates in public comment at the Land Use and Information Committee meetings as well as various other meetings. He is currently serving as the Chair for the Town of Oakland Comprehensive Planning Committee. Mr. Hamilton was asked to present and share his thoughts on what he believes the public is looking for in terms of acceptable location and criteria to be met when the committee is determining approval or denial of an expansion of an existing campground or establishing a new campground in the county. Mr. Hamilton spoke in length on his background in the military and why he thought he was a good choice for the committee to have share at a work group meeting. Mr. Hamilton presented a PowerPoint on his understanding of ACT 67 and county ordinances which pertain to laws and guidelines for county decisions on land use, as well as his thoughts on what the committee should do when updating their ordinances.
