REVIEW SEVERAL OTHER WISCONSIN COUNTY LAND USE/ZONING ORDINANCES FOR INSIGHT AND POSSIBLE SUGGESTIONS FOR UPDATES AND LANGUAGE FOR BURNETT COUNTY LAND USE ORDINANCES The work group reviewed ordinance language dealing with campgrounds from several other counties for possible implementation into parts of Burnett County ordinance language regarding campgrounds. They worked on definition updates, campground types, size limits and zoning district suggestions.

CONTINUE WORKING ON CHAPTER 30 AND CHAPTER 45 LAND USE ORDINANCE UPDATES FOR RECOMMENDING TO THE LAND USE AND INFORMATION COMMITTEE The work group continued to review areas of the land use ordinance with suggested updates to fit the scope of what their recommendations will be to bring to committee after much research on campgrounds throughout the state. Updates agreed upon were discussed, noted and will be put together for review by Vice-Chair Conroy.

DISCUSS ZONING DISTRICTS, PURPOSE AND USE AND POSSIBLE ADDITIONAL MIXED-USE DISTRICT Land Services Director Jason Towne distributed a map of licensed Rec Ed Camps in Burnett County. (Note: one known campground was not listed but could be licensed in another category not shown). The information was reviewed for the recommended mixed-use campground zoning option language to recommend to committee.
