# Last call for legislative map input

People from all over Wisconsin have been abuzz about "gerrymandering" and fair maps for over a year. Voters and county boards from 56 counties have passed referendums and/or resolutions demanding a fair, nonpartisan process be established for decermial redistricting that is now underway. Hundreds of state citizens and community organizations have submitted proposed congressional, legislative and community of interest maps to the People's Maps Commission over the last few months. The PMC recently released and took public input on a set of draft maps that will lead to the release of their final proposal in mid to late October.

Now you have one last call to get a kick at the "gerrymandering cat" and help Wisconsin get fair maps. After the 2020 Census data was released in mid-August, the Wisconsin Legislature opened its own online redistricting map cortal and asked Wisconsin citizens to submit their map ideas for new districts and communities of interest. The website has helpful advice on how to participate using one of three online mapping tools. Many people have since submitted maps, but the opportunity to submit a map ends Friday, Oct. 15.

How can you submit a map of your wn? Go to drawyourdistrict.legis.wisonsin.gov and click on Submit a Plan. ou can draw and submit a district map for the whole state or just your ongressional or state Assembly/Sente district. You can also draw a "community of interest" map that shows any rea, large or small, that affects you.

For me, it was a wake-up call. It would be too easy to lose the natural beauty and resources — especially our waterways — that we have taken for granted for so long. We definitely needed a review and update of regulations to keep developers from overwhelming longtime residents with campgrounds that potentially put resource pressure on townships. We need a balance of activities to respect the rights of landowners, preserve agricultural land, encourage sustainable and appropriate businesses and allow campers to enjoy a more natural, quiet

and sanitary environment.

I value the hard work that the LUIC and Jason Towne, land services director, have done to create and approve updated rules for campgrounds in the county. Their vision for the future seems to restore that balance between economics, the environment, land use and taxpayers' rights.

This summer I spent a week in southern Ohio in a state park. The lake there was lovely – except for one end, where a riotous city of RVs sat almost end to end, by overflowing dumpsters and overworked toilet facilities. This could have been our fate.
