I am voluntarily applying for my child to participate in these activities with knowledge of the danger involved. I am aware that the: Trampoline, Tumble-Trak, Spring Floor, Foam Pit, and Other Related Apparatuses/Equipment are potentially dangerous apparatuses/equipment, and carry risks that include (but are not limited to) muscle strains and tears, broken bones, and severe injuries such as permanent paralysis or death. I am voluntarily applying for my child to participate on all apparatuses/equipment with knowledge of the risk of danger involved. On behalf of my child, I hereby agree to accept any and all risks of my child's injury, relating to any USA STARS program and agree to hold harmless and indemnify USA STARS for and from and claims relating to any such injuries.

**Release:** As consideration for USA STARS agreement to allow my child to participate in these activities listed above, and use all apparatuses/equipment listed above, and use related facilities, I hereby agree on behalf of my child that my child and my child's assignees, heirs, distributees, guardians, and legal representatives will not make claim against, sue, or attach the property or assets of USA STARS as a result of injury or damage resulting from the negligence or other acts, howsoever caused, by directors, officers, insurer, employee, agent, instructor, coach, member, manager, apparatus, piece of equipment, or contractor of USA STARS as a result of my child's participation in cheerleading, dance, tumbling, or other related activities. I hereby release USA STARS and its directors, officers, insurer, employees, agents, instructors, coaches, members, managers, or contractors, from all actions, claims, or demands that my child and my child's assignees, heirs, distributees, guardians, and legal representatives now have or may hereafter have for injury or damage of any kind resulting from my child's participation in cheerleading, dance, tumbling, and related activities. I also hereby release USA STARS and its directors, officers, insurer, employees, agents, instructors, coaches, members, managers, or contractors, from all actions, claims, or demands that my child and my child's assignees, heirs, distributees, guardians, and legal representatives now have or may hereafter have for injury or damage resulting from my child's participation on the Trampoline, Tumble-Trak, Spring Floor, Foam Pit, and other Related Apparatuses/Equipment. Furthermore, the undersigned shall hold harmless and indemnify USA STARS from any and all claims of any such injury or damage hereinabove referenced, including death, whether foreseen or unforeseen.

**Infectious Disease Clause:** By my signature below, I acknowledge my understanding that the novel coronavirus (COVID-19) respiratory infection is confirmed throughout the United States, including Pennsylvania. In accordance with the most recent guidance and protocols issued by the World Health Organization (WHO) and the Centers for Disease Control and Prevention (CDC) and the Pennsylvania Department of Health for slowing transmission of COVID-19, furthermore I understand that USA Stars has put in place preventive measures to reduce the spread of COVID -19 and other infectious diseases; however USA Stars cannot guarantee that you or your child(ren) will not become infected with COVID-19 or other infectious diseases.
