
The Co-working Industry Boom

The Indian co-working space market size was estimated at USD 0.63 billion in FY2023 and is projected to reach USD 1.53 Billion in FY2031, growing at a CAGR of 13.47% from during the forecast period FY2024-FY2031. The trend towards coworking spaces is being driven by the growth of the economy and remote work, which has led to an increasing number of professionals and freelancers looking for flexible and affordable workspaces. As a result, coworking spaces are becoming increasingly popular in major Indian cities such as Bangalore, Mumbai, and Delhi, and are expected to continue to grow in popularity in the coming years.






Franchise Model Overview

This fee entitles you to use the INSTAA OFFICE service mark, use of distinctive system, marketing assistance, ongoing business development and counseling, and other benefits that with being InstaaOffice come franchisee.






FOCO








FRANCHISE PROCESS OVERVIEW

- Step 3: Franchise Agreement Signing
- Legal agreement is finalized, and the franchisee pays the initial franchise fee.
- Step 4:Infra Build In & Training and Setup
- Franchisee undergoes training, and the office space is built out and equipped.
- Step 5: Grand Opening
- Instaa Office supports the franchisee in launching the business, including marketing and promotional efforts.
