Currently, we are providing for nearly 80 animals, including 35+ kittens. Some animals are ready to be adopted, and others will be ready when weaned, vetted, or nursed back to health. Additionally, every day the shelter receives calls asking if we can accept more cats and dogs. # AWL Board Members attend Saline County Town Hall Meeting in the wake of recent dog attacks and inadequate Animal Control services

Concerned about Saline County's recent dog attacks resulting in the loss of a teenager's life and brutal attack on another, plus the lack of financial resources for appropriate animal control in the county, AWL Board Members attended the May 23rd meeting at Benton High School. Present were Beverly Fitzpatrick, Jennifer Hurd, Melanie Marshall, Animal Control Officer Payge Farewell, and POA Community Support Manager Tommy Benfield and his wife Mary. Led by Saline County Judge Matt Brumley, who stated that cases of irresponsible pet ownership, declining revenue from a voluntary tax that was passed in 2014, plus a 3/8 cent sales tax for animal control that was voted down in 2008, have all contributed to the current situation.

"We need real resources to be able to meet the expectations and (implement) the solutions that people deserve in this county," said Brumley, who is in the third year of his first term as county judge.

#### Beverly was the first of 25 speakers who addressed the audience



As reported in the Democratic Gazette, Beverly stressed the need for more spay/neuter enforcement, and explained that Hot Springs Village recently implemented leash laws for pets. She said rules like that can be helpful in preventing dog attacks. Sterilization laws and limits on how many pets a person can own also help. Fitzpatrick also supports something like the failed 2008 ballot issue being reconsidered by the county, especially in the wake of two dog attacks. "I know cities want to be beautiful, but if people aren't safe, that doesn't mean anything," she said. "But safety costs money."

As other speakers shared their stories, Beverly said that the AWL group was shocked to learn about their loss of pets and livestock to dog packs. Most of them said they carried pepper spray with them even to go out to the mailbox. One person even said she waits at the bus for the kids to get off to keep the dogs away from them. The lady that was attacked was in attendance and spoke about her ordeal. She has two pit mixes herself and is a dog lover. Although two dogs were involved in the incident, only one bit her severely several times. The aggressive dog was neutralized, and the other dog ran off and is still being sought.

The general consensus of the AWL group was there clearly needs to be a Saline County shelter, more than just the one current Animal Control Officer, and spay/neuter enforcement.

In conclusion, Beverly said she is "not sure where this will go. Personally, with the recent death of a teenager and the attack on another it should warrant putting the failed 3/8 cent tax on the ballot again. 17 years of this ordeal for Saline County residents is enough." Let's hope the voters agree...

## AWL helps with new "Puppy Program" at Brookhill Ranch



## **AWL Provides Microchip Scanner**

When animals are brought to the shelter, they are always checked to see if they are microchipped, so if lost, they can be reunited with their owners. In the case of feral, stray, or not-so-nice animals, this can be difficult or harmful to check with a standard sized microchip device. To help protect Jim Kull and Payge Farewell, our Animal Control Officers, the AWL purchased a scanner that is much longer in length than standard scanners, and will be easier for them to safely check the animals.

### Keeping Pets Safe during The Long Hot Arkansas Summer

Please keep your pets safe throughout the hot weather! Heat can be dangerous or even deadly for cats and dogs. Dog Walker coordinator Julie Keck advises that when the air temperature is 86F, the asphalt temperature is 135F and can quickly cause severe burns on their paw pads. She reminds us that "If it's too hot for your bare feet, it's too hot for your pets."

#### Just like Humans, Sunburn can lead to Skin Cancer in Dogs

In an article by Health & Wellness Editor Angela Haupt for TIME Magazine, she recently reported that if you want your good boy to have a good summer, make sure he catches balls instead of rays. Dogs can get just as sunburned as people, veterinarians warn, and sometimes, it becomes an emergency. A dog's fur provides some built-in protection against UV rays. But all breeds are susceptible to sunburn—and the lighter or thinner the fur, the greater the risk. A general rule of thumb is that any time you slather sunscreen on yourself, put a pet-safe brand on your dog, too. Canine sunscreen exists and is available at most pet stores.
