 - A. Discuss and approval of our annual Declaration Letter to JPMorgan Chase Bank for our Line of Credit for calendar year 2022. Chief Sattelmaier explained this was an annual process for the District and necessary to fund the District each year to cover financial obligations when there is not enough tax revenue to cover expenditures. The balance of the Credit Line is paid off at the end of each fiscal year. Harry moved and Al seconded a motion to approve. Motion approved unanimously.
 - B. Discuss and approval of the revised Gila County Fire Chief's Association Mutual Aid Agreement. Chief Sattelmaier explained that this Mutual Aid agreement is reviewed and revisited every ten years. The only major change to this new agreement is that includes two Coconino County Fire Districts, Blue Ridge and Forest Lakes. They are being included due to their close proximity to agencies in Northern Gila County and that we work with them on a regular basis. Harry moved and Chris seconded a motion to approve. Motion approved unanimously.
