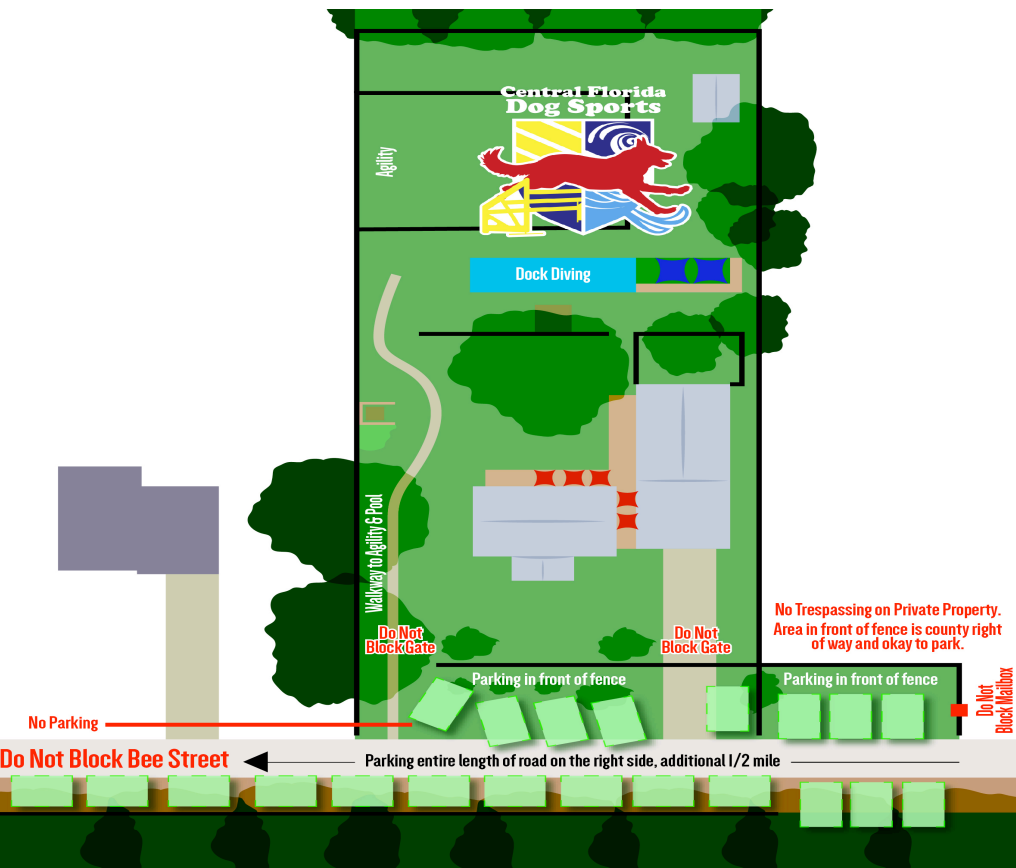
DIRECTIONS TO THE TRIAL SITE

From Orlando: 1-4 to exit 472, take 17-92 Woodland Blvd. North to Spring Garden (15A), turn left at the traffic light go to W. Plymouth, turn left, go to the intersection of Grand Ave and Plymouth (2nd stop sign). Cross over Grand onto Bee St. (sand road) 3rd house on the left.

MEASURING and HEIGHT CARD INFORMATION

Effective January 1, 2010, exhibitors are no longer required to provide proof to Trial Secretaries that their dog has a valid jump height card as part of the check-in process. Furthermore, this change eliminates the need for a copy of the jump height card to be submitted with an entry form. Dogs without a valid Jump Height Card/Form may still compete; but they must be measured/wicketed by the Judge of Record PRIOR to running in their class and this measurement will be valid for that weekend of trials only. The exception to this requirement is a dog entered in the 24" or 26" height division. However, if a Volunteer Measuring Official (VMO) or an Agility Field Rep is present, ALL dogs without a valid Jump Height Card/Form must be measured at some time during the trial or cluster of trials. This does not preclude having the dog wicketed by the Judge of Record if the VMO or Rep is not available to measure the dog *before* its first run of the trial or cluster of trials. It is the exhibitor's responsibility to have their dog measured prior to running and failure to do so will result in the cancellation of any qualifying scores.

Simplified Jump Height Card Process

When filling out the entry form, there is a section at the top of the form for exhibitors to designate whether the dog needs to be officially measured.

Please check the box so that the Trial Secretary knows whether to include the dog on the *Dogs To Be Measured List*. It is not required for a copy of a dog's jump height card to be submitted with the entry form or show it during day of show check-in. However, exhibitors should carry the original valid official jump height card/form at each trial to present upon request. (Ch 2, Sec. 4)

DOG ELIGIBLE TO ENTER

This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), or an AKC Canine Partners listing number, or approved Foundation Stock Service (FSS) breeds are eligible to participate.

Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Wherever the word "dog" is used in these regulations it includes both sexes.

Dogs should be physically sound. Dogs that are blind shall not be eligible, and neither are bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the *Rules Applying to Registration and Discipline* for the listing of registrable breeds that may participate. Puppies under four (4) months of age are strictly prohibited from the trial grounds.

OBSTACLES AND RING CONDITIONS

Obstacles will meet the specifications for obstacles in the current edition of the *Regulations for Agility Trials*. All classes will take place outdoors on a grass surface. Ring size will be 100 x 100 ft.

ENTRY FEES PER DAY

Entry fees per dog, per day are 1st entry = \$23, each additional entry on the same day =\$15 each

If you would like to know the status of your entry prior to the issuance of the judging schedule upon closing, please enclose a self-addressed, stamped envelope or postcard along with your entry. E-mail confirmations will be sent to those listing a legible e-mail address on the entry form.

Express mail entries must include the signature waiver allowing them to be left at the secretary's address. Inquiries may be directed to Cheri Tyre-Roberts at coachx2@gmail.com. No entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance. **Illegible entries** will not be processed and will be returned to the exhibitor. Returned or cancelled checks do not constitute a valid entry and the CFAC will add a \$50 collection fee (optional) to the amount of each returned check.

COURSE WALK-THROUGHS AND WARM-UP INFORMATION

Handlers in all classes are permitted to walk the course, without a dog, during a walk-through period held prior to the start of the class. The walk-through is restricted to handlers entered in that class only. Handlers with multiple dogs, at events with multiple rings may request to walk with a height group other than the one their dog is entered in if a conflict is imminent.

A warm-up area, consisting of one regulation agility jump, may be provided for exhibitors. The warm-up area is to be used exclusively for warming up the dog and not for training or relieving of the dog.

RIBBONS, AWARDS AND PRIZES

Rosettes will be awarded to all dog and handler teams finishing a title

Flat ribbons will be awarded for all placements in each jump height in each class as follows:
First Place-Blue, Second Place-Red, Third Place-Yellow, Fourth Place-White
Qualifying Score Green

NOTICE TO EXHIBITORS

SAFETY, BEHAVIOR and LIABILITY

The safety of the dog is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The **Central Florida Agility Club and CFDS** and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children.

The **Central Florida Agility Club** reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the **Central Florida Agility Club** or any official thereof.

All dogs must be on leash at all times when on trial grounds except when in the designated warm-up area or competing on the course. No FLeXi-Leashes are allowed on the property.

REFUNDS

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee.

Bitches in season will be fully refunded if withdrawn after closing. Notification must be giving to the trial secretary no later than 24 hours prior to the start of the first day of the trial. This club retains the right to refund entry fees after closing in case of extreme emergency of the entered dog/handler.

RINGSIDE

Dogs may arrive any time prior to judging if the dog has a valid temporary or permanent jump height card. Otherwise, they must be available for measuring prior to the start of their class if a VMO or AKC Field Rep is available to measure dogs. All dogs not needed for further judging will be excused.

Judges are not required to wait for dogs. The owner/handler of each dog is solely responsible for having it ready at ringside when it is to be judged. The Club has no responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

This club does not agree to arbitrate claims as set forth on the Official AKC Entry Form for this event.

ADDITIONAL SITE INFORMATION

Crating space - crate space is available, exhibitors may erect tents for additional shade, tents must be securely anchored.

A food concession is not available on the site. There are various restaurants and fast food vendors within a very short driving distance. Door Dash and other delivery services are available.

No overnight parking will be allowed at the trial site. No electrical hook-ups for motor homes or campers are available. RV's are discouraged due to space limitations., **A very nice riverfront KOA is 5 miles from the site.**

Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Trial Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the show grounds.

HOTEL & RV INFORMATION

These hotels accept well-mannered dogs. A pet deposit may be required. Please check with hotels for policies and restrictions.

I (we) certify and represent that the dog entered is not a hazard to persons or other dogs. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

INSTRUCTIONS

Handlers whose dogs measure into 8" through 20" regular height divisions may opt to enter in a higher or 24-choice **height division** for all **regular** titling classes, but not in a division lower than their proper height division. Dogs who measure 24" regular jump height division may not enter 24-choice. Dogs entered in the **Preferred** classes must compete at the required jump height and may not compete in a jump height division higher or lower than their proper height division. All dogs that have not been officially measured for an **Agility Jump Height Card** may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial or **back-to-back trials** only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the **AKC Canine Partners ProgramSM** may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

Junior Handlers should enter their Junior Handler Number on the front of this form. Should you not have your Junior Handler number, it may be obtained from the American Kennel Club (919) 233-9767. If the Junior Handler is not the owner of the dog identified on the face of this form, what is the relationship of the Junior Handler to the Owner?
