JUMP HEIGHTS

Dogs may be entered at any of the following jump height divisions: 4,8,12,16,20,& 24. There are no regular or preferred distinction in the ACT program. A jump height card is not required to enter an ACT event, but handlers are encouraged to have their dogs measured if a VMO is available.

This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), or an AKC Canine Partners listing number, or approved Foundation Stock Service (FSS) breeds are eligible to participate. Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Wherever the word "dog" is used in these regulations it includes both sexes. Dogs should be physically sound. Dogs that are blind shall not be eligible, and neither are bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Rules Applying to Registration and Discipline for the listing of registrable breeds that may participate. Puppies under four (4) months of age are strictly prohibited from the trial grounds.

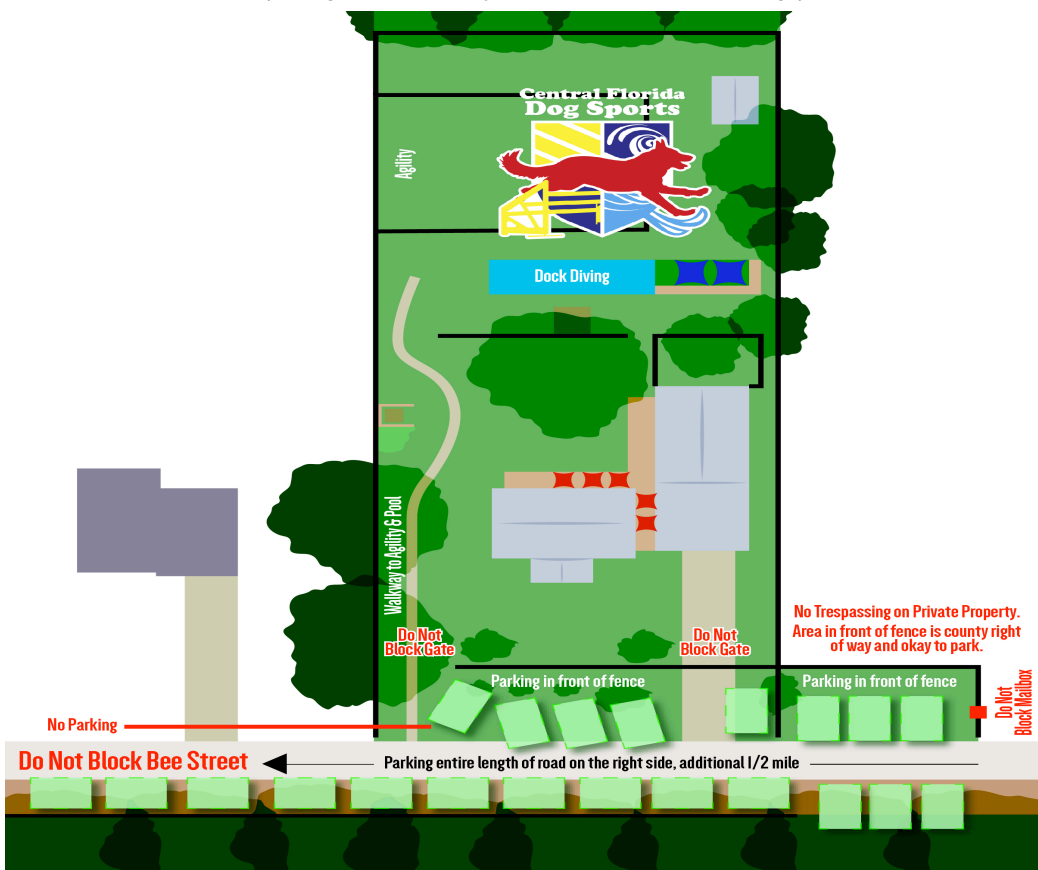
DIRECTIONS TO THE TRIAL SITE

Agility Course Test (ACT) Program

The Agility Course Test (ACT) is an entry level agility event designed to introduce and welcome beginning dogs and their handlers to the AKC sport of agility.

There are two types of ACT courses. ACT Standard – ACT 1 and ACT 2 – which are the beginning level standard courses. Starting February 1, 2021 ACT Jumpers – ACT 1J and ACT 2J – is being added to the ACT program. These are entry level Jumpers courses (no Aframe, Dogwalk, Teeter or Table on courses). ACT 1 and ACT 1J are designed for the beginning dog to show basic sequencing and performance skills. ACT 2 and ACT 2J requires an increased skill level shown by the additional number and types of obstacles to be performed.

In addition to showing their dog's entry level skills, exhibitors will learn to fill out an AKC entry form, check-in at the ring, taking their dog in and out of ring, handling their dog while being judged and other information that will help them when they move on to AKC agility trials with their dog. Dogs must be 15 months old to enter these events. They do not need to be AKC registered at the time of entry.

OBSTACLES AND RING CONDITIONS

Obstacles will meet the specifications for obstacles in the current edition of the *Regulations for Agility Trials*. All classes will take place outdoors on a grass surface. Ring size will be 100 x100 ft.

ENTRY FEES PER DAY

Entry fees per dog pre -entered= \$25, \$30 per run
if additional classes are added day of show. Each
run includes \$5 AKC fee

Express mail entries must include the signature waiver allowing them to be left at the secretary's address. Inquiries may be directed to Cheri Tyre-Roberts at coachx2@gmail.com. No entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance. **Illegible entries** will not be processed and will be returned to the exhibitor. Returned or cancelled checks do not constitute a valid entry and the CFDS will add a \$50 collection fee (optional) to the amount of each returned check.

COURSE WALK-THROUGHS AND WARM-UP INFORMATION

Handlers in all classes are permitted to walk the course, without a dog, during a walk-through period held prior to the start of the class. The walk-through is restricted to handlers entered in that class only. Handlers with multiple dogs, at events with multiple rings may request to walk with a height group other than the one their dog is entered in if a conflict is imminent.

A warm-up area, consisting of one regulation agility jump, may be provided for exhibitors. The warm-up area is to be used exclusively for warming up the dog and not for training or relieving of the dog.

RIBBONS, AWARDS AND PRIZES

Rosettes will be awarded to all dog and handler teams finishing a title

Flat ribbons will be awarded for all placements in each jump height in each class as follows:
First Place-Blue, Second Place-Red, Third Place-Yellow, Fourth Place-White
Qualifying Score Green

NOTICE TO EXHIBITORS

SAFETY, BEHAVIOR and LIABILITY

The **safety of the dog** is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.

It is **expressly understood** that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The **Central Florida Agility Club and CFDS** and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children.

The **Central Florida Agility Club** reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the **Central Florida Agility Club** or any official thereof.

All dogs must be on leash at all times when on trial grounds except when in the designated warm-up area or competing on the course. No FLeXi-Leashes are allowed on the property.

REFUNDS

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee.

Bitches in season will be fully refunded if withdrawn after closing. Notification must be giving to the trial secretary no later than 24 hours prior to the start of the first day of the trial. This club retains the right to refund entry fees after closing in case of extreme emergency of the entered dog/handler.

RINGSIDE

Dogs may arrive any time prior to judging if the dog has a valid temporary or permanent jump height card. Otherwise, they must be available for measuring prior to the start of their class if a VMO or AKC Field Rep is available to measure dogs. All dogs not needed for further judging will be excused.

Judges are not required to wait for dogs. The owner/handler of each dog is solely responsible for having it ready at ringside when it is to be judged. The Club has no responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when requested.

CFDS does not agree to arbitrate claims as set forth on the Official AKC Entry Form for

ADDITIONAL SITE INFORMATION

Crating space - crate space is available, exhibitors may erect tents for additional shade, tents must be securely anchored.

A food concession is not available on the site. There are various restaurants and fast food vendors within a very short driving distance. Door Dash and other delivery services are available.

No overnight parking will be allowed at the trial site. No electrical hook-ups for motor homes or campers are available. RV's are discouraged due to space limitations., **A very nice riverfront KOA is 5 miles from the site.**

Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Trial Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the show grounds.

In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.
