**CALL TO ORDER: Interim Supervisor Phillips** called the September 20th, 2021 Budget Workshop meeting to order at this time, 4:37 p.m. and continued with conducting a page-by-page review of the proposed 2022 tentative budget.

\*\*\* Specific Health Insurance Policy information was not discussed at this time\*\*\*

#### Increases in Fund Balances for 2022 Budget include:

- A1410.2 Equipment (Town Clerk) from \$1,000.00 to \$5,000.00 for new office desks
- A3310.2 Equipment (Highway) from \$30,000.00 to \$35,000.00 for road stripping
- A5132.4 Contractual Expense (Highway) from \$50,000.00 to \$62,000.00 for overhead and man doors
- A9060.8 Hospital & Medical Insurance from \$29,000.00 to \$41,400.00 for the addition of a new benefit eligible employee
- DB5130.2 Equipment (Highway) from \$180,000.00 to \$235,000.00 for the purchase of a new 1-ton pick-up truck
- DB5140.4 Contractual Expense (Highway) from \$9,500.00 to \$25,500.00 for the removal of dead ash trees along the town highways.
  - This money is being moved from DB5140.1 Personal Services (Highway) for the 2022 Fiscal Year. DB5140.1 has been changed to a \$0.00 balance for 2022.

The Schedule of Salaries of Elected and Appointed Officers & Employees was also reviewed at this time.

#### Proposed changes to Employee Salaries for 2022:

#### ✤ 2% increases to the following:

- Supervisor from \$21,000.00 to \$21,420.00
- Council Members -\$3,691.00 to \$3,765.00
- Budget Officer -\$3,500.00 to \$3,570.00
- ✤ 3% increases to the following:
  - Bookkeeper from \$22,000.00 to \$22,660.00
  - Highway/Water Clerk from \$9,274.00 to \$9,555.00
  - Town Justices from \$20,540.00 to \$21,156.00
  - Highway Superintendent from \$37,131.00 to \$38,245.00
  - Code Enforcement Officer from \$57,718.00 to \$59,450.00
  - Code Enforcement Officer from \$40,000.00 to \$41,200.00
- ✤ 6.7% increase to the following:
  - Town Historian from \$1,500.00 to \$1,600.00
- ✤ 12% increase to the following:
  - Assessor from \$41,200.00 to \$46,200.00

\*\*\*Town Clerk/Tax Collector & Deputy Highway Superintendent are to receive no increase for 2022\*\*\*

- Highway Employee (MEO-Light)

Other Changes Made to Pay and Salaries:

- Highway Employee (MEO) from \$26.91 per hour to \$27.45 per hour
- Health Officer decrease from to \$1,500.00 to \$500.00
- ♦ Water Superintendent increase from \$2,500.00 to \$5,000.00 due to the elimination of the Assistant Water Superintendent position.
