



PARROT PALACE EXHIBIT ASSUMPTION OF RISK, RELEASE OF LIABILITY, AND RULES AGREEMENT

By entering or participating in the Parrot Palace LLC exhibit, I acknowledge and agree to the following:

1. Voluntary Participation

I understand that I am voluntarily participating in an interactive exhibit involving live birds and exotic animals. I understand that interaction with animals involves inherent and unavoidable risks.

2. Assumption of Risk

I acknowledge that birds and other animals may bite, scratch, peck, flap wings, grab clothing or jewelry, land on persons, cause allergic reactions, transmit bacteria or germs, or otherwise behave in unpredictable ways. I further understand that slips, falls, or other injuries may occur within the exhibit area. I knowingly and voluntarily assume all risks, whether known or unknown, associated with entering or participating in the exhibit.

3. Rules and Safety Requirements

I agree to follow all posted rules, verbal instructions, and directions provided by Parrot Palace staff at all times. This includes, but is not limited to:

- No placing fingers, hands, food, or objects inside cages or enclosures unless specifically permitted by staff.
- No teasing, chasing, striking, grabbing, or provoking animals.
- Supervising all minors in my care at all times.
- Immediately reporting unsafe conditions or injuries to staff.

I understand that failure to follow rules or staff instructions may result in removal from the exhibit without refund.

4. Release and Waiver of Liability

To the fullest extent permitted by law, I hereby release, waive, discharge, and hold harmless Parrot Palace, its owners, officers, directors, employees, volunteers, agents, affiliates, successors, assigns, landlords, and representatives from any and all claims, demands, causes of action, damages, liabilities, costs, expenses, or injuries of any kind, including personal injury, illness, property damage, or death, arising out of or related to my participation in or presence at the exhibit, including claims arising from the ordinary negligence of Parrot Palace.

5. Responsibility for Personal Property

I understand that Parrot Palace is not responsible for lost, stolen, or damaged personal property, including phones, jewelry, eyeglasses, clothing, bags, or other belongings.

6. Medical Consent and Fitness to Participate

I affirm that I am physically able to participate in the exhibit and have no medical condition that would make participation unsafe for myself or others. I understand that I am responsible for any medical expenses arising from injuries or illnesses related to participation.

7. Minors

If I am signing on behalf of a minor, I represent that I am the parent or legal guardian of the minor and consent to the minor's participation. I agree to assume all risks on behalf of the minor and release Parrot Palace from any claims brought by or on behalf of the minor to the fullest extent permitted by law.



8. Photo and Video Consent

I understand that photos or videos may be taken within the exhibit for promotional, educational, or social media purposes. By entering the exhibit, I grant Parrot Palace permission to use my image or likeness without compensation unless I notify staff in writing prior to entry.

9. Severability

If any provision of this agreement is found to be invalid or unenforceable, the remaining provisions shall remain in full force and effect.

10. Biosecurity and Sanitation

I understand that for the safety and health of the animals, guests, and staff, all visitors are required to sanitize or wash their hands before entering and upon exiting the exhibit area. I agree to comply with all sanitation and biosecurity procedures established by Parrot Palace, including any restrictions regarding food, beverages, outside items, or contact with animals. I understand that failure to comply with these procedures may result in removal from the exhibit without refund.

11. Governing Law and Venue

This Agreement shall be governed by and interpreted in accordance with the laws of the State of Missouri, without regard to conflict of law principles. I agree that any claim, dispute, or legal proceeding arising out of or relating to participation in the Parrot Palace exhibit shall be brought exclusively in a court of competent jurisdiction located in Cape Girardeau County, Missouri, and I consent to the personal jurisdiction and venue of such courts.

12. Acknowledgment

By entering the exhibit, I acknowledge that I have read and understood this agreement, fully understand its terms, and agree to be legally bound by it.
