Pinal County Public Health Dashboard Overhaul

- Allows for custom URL creation
- Allows for analytics on data to determine the effectiveness
- Includes info on specific topics (substance misuse, diet, etc.)
- Comprehensive list of community health partners
- Allows for the possibility of a community calendar for events and other meetings
- The overall goal is to better depict the health picture in the community of Pinal County --Suggestions included: assisting people in understanding the language that will best help them access the care they need

Community Health Needs Assessment (CHNA)

 Identifies key health needs and issues through systematic, comprehensive data collection and analysis

Community Health Improvement Plan (CHIP)

- Uses CHNA data to identify priority issues
- Develop and implement strategies for action
- Establish accountability to ensure measurable health improvement

CHIP Priorities for 2020

- Substance Misuse & Dependency
- Mental Health
- Nutrition & Physical Activity

Overarching goals

- · Improved coordination and collaboration with community partners and providers
- Development of Resource Guide; improved promotion of existing resources and services
- · Improved data collection, visualization, and sharing

Regulatory

- The Patient Protection and Affordable Care Act Section 501(r)(3)(A) requires a hospital organization to conduct a community health needs assessment (CHNA) every three years to adopt an implementation strategy to meet the community health needs identified through the CHNA.
- Public Health Accreditation Board requires a community health assessment (CHA) every five years

CHNA & CHIP Revisions for 2022-2023

- Primary and Secondary data focused on Community Health Status, Community Themes and Strengths, and Local Public Health System
- Achieve this through, surveys, focus groups, local and county, and comparative state and federal data, CHNA Community Survey: Questions for the three priority areas
- Other Sources from Partners (2020-2022): data collection, surveys, reports
- Suggestions included, including TRAUMA and ACEs data; constantly refreshing the language in surveys and data collection methods





Arizona Criminal Justice Commission

2020 ARIZONA YOUTH SURVEY Responses from over 30,000 8th, 10th and 12th grade Students Reveal Decreased Drug Use Among Arizona Youth Statewide

The Arizona Criminal Justice Commission (ACJC), the leading criminal justice resource agency in the state released the results of a statewide survey that included more than 30,000 students in 8th, 10th, and 12th grades from 13 counties across Arizona. The Arizona Youth Survey (AYS) is the primary vehicle used in Arizona to collect data and provide one of the most in-depth and comprehensive looks around at-risk behaviors in Arizona youth.

The 2020 AYS was scheduled to be administered between February and May 2020, but a second survey period was administered between September and November, 2020 after the Spring administration was interrupted by school closures due to the COVID-19 pandemic. This resulted in the participation of 30,052 students from 152 schools across Arizona.
