Marcos**, holder of Philippines driver license number C10-16-020916 issued on 10-04-2018, expiry on 05-04-2024, representing **Global Infrastructure Development and International Finance Agency** (hereafter known as **"GIDIFA"**) in my capacity as Permanent Secretary General and Global Ambassador (hereafter known as **"Principal"**) declare, under penalty of perjury and with full personal responsibility, that with this formal letter I am ready, willing and able to

APPOINT

The Honorable **Mr. Patrick Dwayne Johnson**, holder passport of the Kikiallius Nation a Sovereign Nomadic Indigenuos People number: 242508-204 issued on 08-12-2019, expiry on 11-08-2023 (hereafter known as **"Under Secretary"**) with the office of Under Secretary for Redistribution of Funds and Creation of Virtual and Credit Currency in name and behalf of the Principal and GIDIFA.

The Honorable **Mr. Patrick Dwayne Johnson** can operate separately and independently under my direction and instruction, with authority in his personal name, or the Principal and GIDIFA behalf with powers to adopt all the necessary actions to instruct, assist, educate, arrange and manage any and all operations with third parties pertinent to the Redistribution of Funds and the creation of Virtual and Credit Currency in accordance with the International Laws, Rules and Regulations.

The Honorable **Mr. Patrick Dwayne Johnson** in his role has no signatory powers to represent GIDIFA or the Principal and he has not executive capacity, as well as he is not authorized to assume all authority, powers, duties, signatory rights and responsibilities on name and behalf of GIDIFA, except for specific matters where he is appointed in written way regarding the purposes of this Authority.

I, the undersigned, the Honorable **Mr. Angel Ferdinand M. Marcos**, as Principal, I hereby certify, under penalty of perjury, that this Authority will remains in full force and effect indefinitely until my revocation or my death or until the Under Secretary's revocation.

The Honorable **Mr. Patrick Dwayne Johnson** is empowered to freely act pursuant to the terms of this Authority without any power to transfer the same to third parties.

This Authority right, written in two copies and authenticated by the Principal can be used by the parties for any legal act. The same does not provide for payment of remuneration.

This Authority right is subjected to the laws of Non-Solicitation and Non-Circumvention and Non-Disclosure in accordance with the Regulations issued by the ICC latest edition 400/500/600 and following of Paris and which will be valid for a period of 5 (five) years from the signing of the last executive contract between the parties.


