
Penticton Indian Band recognizes: **John Bush** (USA) with Date of Birth: 06-02-1950) | SERV. JOHN™ ((Plum Blossom Society)*Chen Family Referred) as HONORARY DIPLOMAT (to be registered in USA and AFRICA), appointed to represent Chen Family Dynasty of Plum Blossom Society, and through the indigenous bands of Penticton Indian Band, and Philippines 1st Nations, under the treaties with General Angel Ferdinand Marcos Marcos, and with Kikiallus Nation signature of the "i" Band, with special rights as an Honorary Diplomat, Honorary Consulate, and qualified Trust Advisor of our tribes and families. This role of service is appointed to empower Matriarch Q, and Plum Blossom Society in their goals to Unlock Humans.


As Honorary Diplomat for our tribes and family, John Bush reports to no council members within Penticton Indian Band, Okanagan's Syilx people courts, nor to 1st Nations through Plum Blossom Society. John Bush operates in a private council and Indian Confederacy registered as LIGHT™, solely under the Chen Family Dynasty veil. John Bush must have a co-endorsed signature on all treaty or related material to our tribes, with Chief LightKey EnJin's signature showing (with ID), for documents to be valid and recognized by our tribal bands and families.

John Bush has the permission to be an Account Signatory and Board Director representing Penticton Indian Band and Okanagan's Syilx people with negotiations, acquisitions, strategy, accounts, estates, IP, diplomatic treaties, contracts, and assets registered through LIGHT™, or within LIGHT™ Series Trust, HARMONY SYSTEM™ Series Trust, and 7TH SEAL™ Series Trust, on behalf of Matriarch Q and Plum Blossom Society through the Chen Family Dynasty. In the case of an emergency or inability to attend appointments, John Bush may attend meetings and sign for Chief LightKey EnJin.

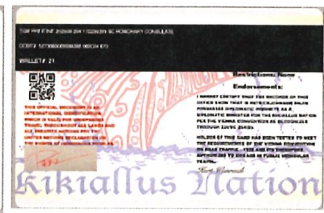
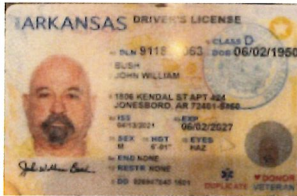
