Lessee agrees that it will indemnify, hold and safe the Town of Salley, their officers, agents, contractors and employees whole and harmless and at Operator's option defend same, from and against all claims , demands, actions, damages, loss, cost, liabilities, expenses and judgments of any nature recovered from or asserted against Operator on account of injury or damage to persons or property to the extent that any such damage injury may be incident to, arise out of, or be caused, either proximately or remotely, wholly or in part, by an act, omission, negligence or misconduct on the part of Lessee or invitee or of any other person entering upon the Premised leased hereunder with the express or implied invitation or permission of Lessee , or when any such injury or damage is the result, proximate or remote, of the violation by Lessee or any of its agents, servants, employees, contractors, patrons, guest, Lessees or invitee of any law, ordinance or governmental order of any kind or when any such injury or damage may in any other way arise from or out of the occupancy or use by Lessee, its agents, servants, employees, contractors, patrons, guests, Lessees or invitee for the Premises leased hereunder.
