Brothers, the past year has been one of change, not only for the Knights of Columbus in this jurisdiction, but for the Order worldwide. For this jurisdiction, the changes began with the election of a new executive at the 101st Annual State Convention in Gander in April 2019.

And those changes continue to influence the direction this jurisdiction, and all others in the K of C world, are taking. An example is the upcoming State Convention, just a little over a week away.

Brothers, as you are aware by now, this will NOT in any way, shape or form, be a conventional Knights of Columbus Annual State Convention.

The worldwide COVID-19 Pandemic has played, and is continuing to play, havoc with the plans of not only the Annual State Convention for this jurisdiction, but also with State Conventions for ALL jurisdictions in the Knights of Columbus world.

For many weeks now, staff at the Supreme Office have been scrambling to try to prepare a workable Virtual State Council Annual Meeting. We will see and experience the results of that work, as we hold the first ever Virtual Annual Meeting of the Knights of Columbus in Newfoundland and Labrador on Saturday April 25, 2020.

In this, the 102nd year, annual the meeting of brother Knights is being done virtually. Each council in the jurisdiction will still pick delegates to attend the Annual State Convention, but those delegates won't be required to travel to take part in any meetings. They will participate from the comfort of their own homes.

Another change came about at the November Organizational Meetings for State Deputies in Orlando, Florida. That was when the Supreme Knight introduced a new combined ceremonial, which will mean significant

changes to the way things are done in the Knights of Columbus world. The new ceremony, known as ‘The Exemplification of Charity, Unity and Fraternity’ removes

the barriers of secrecy and commitment of time that many Catholic men have found difficult when invited to join our ranks.

Enthusiasm has grown quickly and continues to grow for this change. In fact, early in 2020, the new combined degree was used at a ceremony in Sheshatshiu, Labrador at which time seven members of Canada’s First Nations became members of the Knights of Columbus.

Now another change is coming, and it is connected to the new combined degree as well. The Supreme Council has developed an Online Exemplification that allows men to join the Order while still observing the stay at home orders imposed by state and local governments due to COVID-19. You won’t need to travel outside your own home to join and become a full-fledged member of the Knights of Columbus.

Brothers, some of the changes we are experiencing were planned, others weren’t. But we are working through them all. And, we will get through them.

As the Coronavirus battle wages on, plans are being made, then revised and changed again, sometimes daily, to provide the necessary tools and guidance for our councils to continue their mission of charity and service. The Supreme Council has just released a new program, “Leave No Neighbor Behind”, a new K of C initiative for a worldwide response to the Coronavirus Pandemic. Every council in this jurisdiction has been provided

with a handbook on ways and means to incorporate this new initiate into their activities and operations.

May God bless and protect each one of you and your families in this great order that we serve.

Message from District Deputy #3

Brother Knights;

All is quiet on the Eastern Front. What a tormentous time for our communities. We thought the isolation of snowmagenddon was severe then we are subjected to COVID 19 pandemic. I urge all members to follow the guidelines from the government in order to

protect yourselves and you families from this pandemic. Our methods of activities have changed but the underlining principles of our order is still being followed. The executive of the councils is still meeting through electronic means and some of our good works are still continuing, such as food banks. I recommend that you contact your brother knights to stay in contact and help when necessary. This may be as simple as to pick up prescriptions or food especially for those in higher risk medical conditions.

The councils in District #3 comprise of Fr. JB Kent 6638, Mary Queen of Peace 7405, Holy Trinity 9807 and St. Paul's 11776. Each council continues their activities in the four program areas that support their parishes and community. The complete list of activities is too long to list here, however there are some exceptional activities that need to be acknowledged. Fr. JB Kent council supported their parish by donating \$15,000 for a Propane generator to prevent flooding at the Rectory during a power outage, providing financial assistance to St. Vincent de Paul and The Gathering Place to feed the hungry. Also FR. JB Kent Council conducted the New combined degree on March 14 the first on the Avalon Peninsula. Five new members went through the new degree and I must say it was performed exceptionally. An invitation was extended to other councils in the vicinity to attend.

St. Paul's Council continues to participate in the coats for kids' program to cloth the poor, laying wreaths to remember the brave people that fought and died for our freedom. Also St. Paul's provided the second installment of \$30,000 for the development of a multipurpose field for the youth and the community in general. This program took

fifteen years to complete with the cooperation of the Roman Catholic Archdiocese of St. John's, NL Eastern School Board, City of St. John's, Govt. of NL and the Govt. of Canada. This field is only one of its kind in St. John's and the second in the province. This field can be used for any field sport and has a track around its perimeter for the athletes.

Mary Queen of Peace council assembled and paraded a KEEP CHRIST IN CHRISTMAS float in the St. John's Christmas Parade, the only float bearing the true meaning of Christmas. Holy Trinity council continues to support their parish by operating the parish hall and participating in the Parishes Garden Party and Torbay's Christmas parade

Each council has the complete support of their Parish Priests and are planning to continue to support them. I applaud each council in their spiritual and corporal works of mercy and offer my assistance to support their activities anyway I can.

Message from Online Membership

Worthy State Deputy, Worthy State Chaplin, Brother Knights, Supreme, as you know, has developed an online way to recruit potential members and form those men for committed, lifelong and council-based membership in the Knights of Columbus. And thus, since July 1, 2018, eligible Catholic men have been able to join the Knights of Columbus online.

During the past year there were 5 members who joined the NL State Council 98059 online, and 4 of these members have migrated to individual Councils within the province.

Since I was appointed Online Membership Chairman about a year ago, Grand Knights have been encouraged on a regular basis to promote online membership as an option for men who are not yet ready for council-based membership. Councils have been reminded that this initiative is not meant to replace traditional recruiting methods; council members still have to take the initiative to ask eligible Catholic gentlemen to join the Knights.

Councils in our jurisdiction have been encouraged to endorse this online option at every opportunity when speaking about the Knights of Columbus. As well, Councils have been encouraged to support the Online Membership option through promotions on Council Webpages, Face Book Pages, advertisements in Church Bulletins, etc.

Councils have been made aware of the many complimentary resources, booklets, brochures,

cards which are available from Supreme, and to have these on hand when needed.

Councils have been encouraged to check out the information which is available online at the Supreme web site.

Throughout the past year, I have kept in contact with our State membership director, Brother Pat Gambin, and have promoted the Online Membership on the State web site.

When prospects have joined online, personal contact has been made by phone or email, and when prospects have indicated a Council preference, efforts were made to get the prospect and individual councils in contact with each other.

The Knights of Columbus continues to change and evolve to meet the needs and conditions of a changing world, and online membership may be one of the first steps in getting new members engaged in our many charitable and fraternal activities.



Message from State Ceremonials Chairman

Brothers: ceremonials are a primary importance of the growth and strength of the Knights of Columbus. Ceremonials plays a very important role in each of the order's rules from the Installation of Officers, Degree Exemplifications, Council Meetings and Proper Protocol. While ceremonials demonstrate Fr. McGivney's vision, it also advances new members through degrees, members who observe this passage will benefit from a rekindled spirit of Columbianism as a result of their attendance.

From July 01, 2019 to December 31, 2019, thirteen First Degree exemplifications were completed in our jurisdiction with an intake of 42 new members. In January 2020 Supreme Council announced proposed changes to the degree structure in the Knights of Columbus World.

Effective January 15, 2020, the three separate degrees, Admission, Formation and Knighthood was rolled into one degree namely a Combined degree of Charity, Unity and Fraternity. With degree secrecy eliminated, its preferable that the degree to be held in church or other menu with the candidate's family, friends in attendance. It can be done in approx. 30 minutes with five members, a Leader, Warden and one each for lessons of Charity, Unity and Fraternity.

Any member doing the combined degree will become a third-degree member at the one exemplification. Those 1st or 2nd degree members can attain their Knighthood degree at one seating. Also, with this change, robes has been replaced with the wearing of Baldric along with your dress attire.

To date there has been three successful exemplifications by using the combined degree with an intake of 10 new members and two 1st degree members totally 12 attaining status of Knighthood. The intake for new and former members for this jurisdiction stands at 58.

Special thanks to the members of the Admission, Second, and Third-Degree teams for devoting their time in practice & performance of the exemplifications of thousands of members to our order prior to this major change. We continue to depend on these same members to participate in the new Combined degree in the exemplifications of members to our Order.

History recalls how we humans have overcome and we learn from our past the pathways to our future. Here are a few examples from the past when humankind arose above and beyond the disasters. You remember them all and more.

Spanish Flu

The Spanish influenza pandemic of 1918-19 killed between 20 and 40 million people worldwide, making it one of the most destructive outbreaks of infectious disease in recorded history. It first appeared in Newfoundland Labrador in September 1918 and killed more than 600 people in less than five months.

The effects were most devastating in Labrador, where the disease killed close to one third of the Inuit population and forced some communities out of existence.

By February 1919, the epidemic had largely ended on the island, although traces of it remained until the summer. Before it disappeared, the disease killed 170 people in rural Newfoundland. Although its effects were both devastating and far-reaching, the influenza spread through Labrador in a matter of weeks, killing more than 30 per cent of the Inuit population and infecting many others.

Those who did not die from the disease often experienced heart and respiratory troubles for the rest of their lives.

Elections

Brothers,
There have been numerous requests about clarification on the election of Council and Fourth Degree Assembly officers for the upcoming year in recent weeks.

As such, I requested a ruling from Supreme on that matter on April 8, 2020. On April 14, 2020, I received a reply to my e-mail, the e-mail indicated it would be appropriate for Councils and or Assemblies to conduct virtual meetings to elect their slate of officers for 2020-2021.

Subsequently we received further correspondence wondering if elections for Councils and or Assemblies could be deferred, rather than being held by way of virtual meetings. Reply from Supreme stated that it would be acceptable for a Council or Assembly to defer their elections for 2020-2021 until after the COVID-19 crisis eases, and that if those elections did not take place until late summer or early fall, that would be acceptable as well.

The only stipulation being that

if a Council or Assembly defers its election of officers beyond July 1, 2020, a form 185 must be completed and submitted to Supreme. this form 185 will contain the names and positions of the officers in place at the time the election was deferred. Then, after an election is held, a new form 185 must be submitted containing the names and positions of Brother Knights elected at that time, whether everything remains the same, or not.

The decision on whether to defer the Council or Assembly Election is ‘**ENTIRELY**’ up to each individual Council, and or Assembly. Neither State nor Supreme will object.
