Message from State Treasurer



Greetings Brother Knights. Welcome to the new Colombian year. As your newly elected State Treasurer, it is my responsibility to administer and manage all funds of the State Council which are received from all sources and deposited to our State accounts. I also make sure all approved expenses; invoices, and State donations are paid on time.

The primary operating funds used at the State level are realized from assessments received from our subordinate Councils, our proceeds from the Annual Fall Ticket Sweep and the \$40 Ticket lottery as well as some small donations and other sources.

Please ensure your Council assessments, when invoiced, are paid promptly. Travel medical claims are processed as soon as they are received. Claims for this benefit are paid throughout the fiscal year starting on March 1st2019 up and to Feb 28th2020 with a 30-day, grace period till March 30th, 2020.

We occasionally get claims for travel reimbursements which are sometimes held for long periods of time please submit your member travel claims early.

Message from State Advocate



First of all, I would like to thank all Brother Knights for their confidence in choosing me as your State Advocate.

As the State Advocate I am responsible to pass on and oversee legal matters of the Order, those that are received from the Office of the Supreme Advocate and legal questions that may arise from Councils.

I attended this year's Supreme Convention and am happy to report that the resolutions submitted by this jurisdiction were well received. The Supreme Advocate's Annual Report presented at the convention was informative and highlighted several points that have a direct impact on our jurisdiction.

Safe Environment Compliance. Safe Environment Requirements are of paramount importance to the Knights of Columbus. Our jurisdiction must ensure that Councils complete the required training and that the appropriate council personnel are compliant. Keep in mind that this is a requirement for the STAR Council Award.

Home Corporations. At the 132th Supreme Convention in 2014, the Supreme Council adopted a resolution establishing a policy for

Councils to follow with regards to Home Corporations. Five years later the Supreme Advocate has again stated that Councils with Home Corporations are still not following procedures outlined in the policy. This is something I will address.

Officers' Desk Reference. To assist members who have leadership responsibilities Supreme has developed an online tool called the Officers' Desk Reference, located on the Supreme Council's website on Officers Online. Each Council Grand Knight and Council Advocate should familiarize themselves with this important tool as it provides definitive guidance on the Constitution and Laws of the Order. The guidance published on the Officers' Desk Reference is binding on Councils of the Knights of Columbus, their officers, and members, to the extent set forth by the Supreme Advocate.

This tool is not new to us, but I feel that it is not used to the extent that it should. Numerous questions can be answered if only councils and their officers use this valuable resource.

Those are just a few points that I intend to focus during my tenure as your State Advocate. All Grand Knights and indeed all Council officers are welcome to reach out to me as your State Advocate on any legal matter that may affect your council.

I look forward to meeting old friends and meeting new friends at our Mid-Year meetings at the end of November.

Message from State Faith Director

Brother Knights,

In support of the faith life of our Brother Knights, their families and parish communities, the Knights of Columbus encourages Grand Knights to promote faith-based activities in their councils. A number of activities are recommended.

Councils are encouraged to help build the Domestic Church, most notably by setting up a Kiosk of faith-based literature in the Parish Church with documentation available from the Catholic Information Service. Steps to take on this dossier are outlined in the booklet distributed to you by the State Council.

A second activity encouraged by the Supreme Council includes the organization of regular Holy Hours. While I doubt that this activity will appeal to many Knights in Newfoundland and Labrador today, I encourage those interested to contact your Parish Priest to organize a first Holy Hour in order to gauge interest.

In a third activity recommended by the Supreme Council, Councils are encouraged to form discussion groups for the study of *Into the Breach*, an apostolic exhortation by Bishop Thomas J. Olmsted. This exhortation outlines the challenges faced by men of faith in the world today. Again, details for the organization of study groups may be obtained through your Grand Knight.

Other programs recommended by the Supreme Council include the Marian Icon and Rosary Programs, as well as the RSVP programs. The first two speak for themselves

and the third involves support for seminarians and other religious vocations. For every \$500 donated to an individual seminarian, the Supreme Council will refund \$100 back to the council - up to a maximum of \$400 per council per fraternal year. If you have donated money and have not already requested your refund, I urge you to do so at your earliest convenience.

If I may be of service in any of these areas, please feel free to contact me and I will do my best to answer any questions you might have.

RESOLUTION NO. 337 REAFFIRMING POLICIES REGARDING HONORS FOR PUBLIC FIGURES

WHEREAS, the Knights of Columbus has made the sanctity of life at all stages a cornerstone of our mission that is directly informed by our foundational principle of Charity; and

WHEREAS, since the mid-20th century, the legal practice of abortion in the many countries where we are active, most notably in the United States and Canada, has corroded the very heart of society and led to the death of millions; and

WHEREAS, in February 2019 Pope Francis stated very clearly that all new lives conceived “are children of the entire community, and their being killed in large numbers with the backing of the state constitutes a grave problem that undermines the foundations of the building up of justice, compromising the correct solution for every other human and social problem;” and

WHEREAS, Pope Francis has also called on politicians of all faiths and nationalities, “to treat the defense of the lives of those who are about to be born...as the cornerstone of the common good,” and that on this issue policy makers should not be, “conditioned by mindsets that focus on personal success...or one-sided interests;” and

WHEREAS, polling sponsored by the Knights of Columbus and Marist College has consistently found that a bipartisan supermajority of Americans support

enhanced restrictions on abortion with most recent polls showing strong majorities of Americans believe taxpayer dollars should not be used to support abortion domestically or abroad; and

WHEREAS, despite this strong majority support for prolife positions, politicians continue to promote laws that allow abortion until the moment of birth and oppose simple, commonsense protections for children born as a result of a failed abortion or policies that prohibit taxpayer dollars to fund abortions.

THERE FORE BE IT RESOLVED, that the Knights of Columbus reaffirms our decades-long policies of not inviting to any Knights of Columbus event, persons, especially public officials or candidates for public office, who do not support the legal protection of unborn children, or who advocate for the legalization of assisted suicide or euthanasia; and

FURTHER RESOLVED, that we prohibit our members from allowing such persons to rent or otherwise use facilities over which our members have control; speaking at Knights of Columbus events; bestowing on them honors or privileges of our Order of any kind; inviting them to serve as honorary chairpersons of events, celebrations, or committees; or, hold any office in the Knights of Columbus; and

FURTHER RESOLVED, we commit ourselves to praying that all public officials realize the evils of the culture of death and enact policies that recognize the sanctity of every human life.

State Membership Directors Message

Brother Knights, welcome to another year in MEMBERSHIP RECRUITMENT in our jurisdiction. We are presently into the third month of the Columbian Year 2019-2020 and we have had a fairly successful Summer in recruiting, which resulted in having 11 new/former members join the Knights of Columbus. At the present time we have recruited 19 new/former members to our ranks. This is a very good start in reaching our goal of 130 members for 2019-2020 and giving our jurisdiction the distinction of earning the Circle of Honour Award this year, which is a very attainable goal. During the weekend of September 21-22, 2019, the State Executive, held a training session with District Deputies, Grand Knights and other Brother Knights from the Avalon Peninsula area on MEMBERSHIP Recruitment and Council Officers training. This session was led by Denis Belanger, Regional Training Director from Supreme office. It was very well-received by the 30 participants and was very informative. After the training session was completed, most State Executive members and local Knights, including District Deputies, Grand Knights and other Brother Knights from the area, held 2 Church drives at St. Peters Church in Mount Pearl on Saturday evening and Sunday morning. This was led by Denis Belanger and a total of 38 prospect cards were collected as a result. A couple of more prospects also signed prospect cards as a result of one attendee from the meeting mentioning the fact of recruiting at a social function. This resulted in interest from a former member and also a new member. If percentages hold true, we hope to have a fair number of these prospects who will join one of our councils very soon with follow-up from the District Deputies and Grand Knights who have been assigned to do so.

Thank you to all who participated in the weekend session and especially the 2 Church drives.

As your State Membership Director, I want to strongly encourage all councils to promote a Church drive in October and again in February/March to make another step toward achieving your councils goal in Membership for this Columbian year. Together, we can grow membership in our jurisdiction of Newfoundland and Labrador with each individual member taking responsibility for recruiting, at least, ONE new member this year. After all, Membership is EVERYONE'S RESPONSIBILITY!

No pun intended but if you LOOK to the end of this Columbian year you will SEE that it is 2020, (twenty-twenty), which is considered perfect vision. We can all SEE that the future of the Knights of Columbus worldwide depends on bringing in New members to keep our programs and activities going to continue the great works we do. Worthy Knights; At the end of many Knights of Columbus letters we receive in the Salutory Line or Salutation immediately before the Signature Line the salutation Vivat Jesu(s). [In Latin Jesu is the translation] Where did this brief prayer come from and how did it come into ordinary usage. Why do we use it as a sign of our membership in the Knights of Columbus?

The immediate answer is clear biblical and theological thought. "I am the way, the truth and the life. No one comes to the Father except through me."

But a story goes with it.

A young man named Francis de Sales was a student of the humanities and philosophy at the Jesuit College of Clermont in Paris 1580-88 and went on to the University of Padua to earn a Doctorate in Law in 1591. Subsequently he studied for the priesthood and was ordained in 1593. He was an ordinary man with many gifts. He is a Doctor of the Church.

Among his books is a book that is required reading even today at all Catholic Seminaries viz. "Introduction to the Devout Life." It's a classic spiritual text and in it he carefully explains his spiritual instructions to Marie de Chastel, a maid of honor in the household of Catherine of Cleves how to live a devout life.

The "Introduction" is divided into 4 parts consisting of 15 to twenty meditations. And at

the end of several we find our Salutation in its more complete form. In part one he ends several meditations with the prayer:

“Oh my God! Thou art my God, the God of my heart, the God of my soul, the God of my spirit. As such I acknowledge Thee, and as such I adore Thee now and forever. Live O Jesus!”

In another place he writes:

“Oh, holy Virgin! Beloved Mother! I choose thee for my guide. I put myself under thy protection. I offer thee a particular respect and special reverence. Oh, my good angel! Present me to this sacred assembly. Forsake me not until I am joined to this blessed company, with whom I say and will say forever in testimony of my choice: Live Jesus, Live Jesus!”

Often the press of meetings, activities and business may distract us. But we must all remember who we are. Practical Catholics and Christ Bearers. We are frequently alerted to this fact when we view our lapel pins and logos and use the salutation Vivat Jesus.
