Message from Districty Deputy #1

Brother Knights:

The three councils in District 1 were busy during July and August planning for arrival of the Blessed Michael McGivney relic. During September, all three councils, Dalton Council, Avalon Council, and Msgr. McCarthy Council had different events planned. Sunday Mass was celebrated in 5 different churches, St. Joseph's Kingston, St. Patrick's Carbonear, St. Joseph's Riverhead, All Hallows in North River, and St. Patrick's Brigus. Four different priests were involved in the different parishes: Father Alejandro Credo. Father Anthony Nwoko, Father Julius Nwosu, and Father Emmanuel Osuagwu.

Rosaries were prayed in the homes of brother knights, widows, families, council chambers, and in two cemeteries, Immaculate Conception Cemetery and St. Patrick's cemetery.

The Relic was also present for the Installation of Officers at Msgr. McCarthy Council, Carbonear, and the Fourth Degree Installation of Officers at Dalton Assembly, Harbour Grace.

All in all, the reception and veneration of the relic was a great success and a great contribution to the prayer life of parishioners in this area. It was extremely meaningful to bring the relic to Brother Knights and widows who were unable to attend the public venerations. Kudos to those who helped to organize, carry out, and participate in the different events.

Brothers,

We accomplished our mission in achieving the Circle of Honor for our jurisdiction, the first such achievement since 2008-2009. Congratulations to all who went the extra mile to ensure this was achieved. Thank You! Special thank you to PSD Pat Gambin, online director Sir Knight Gerard Butt, GK Wayne Furlong, Terra Nova Council, who at the last minute recruited 2 online members to put the jurisdiction over the top, and all District Deputies, Grand Knights and members who did their part to make this happen.

We now set our goals on this Fraternal Year. We can do this again. However, we need many more members especially our leaders who must take recruiting members more seriously. As leaders in this jurisdiction and if you have not recruited a member in years, can you honestly say that you have recruitment at the top of your priority list? Let's all put it there this year so that come June 30, 2024 we can all say "I did my part".

Brothers, we are constantly reminded that membership is

the backbone of our Order. Without recruitment of new members, the writing is on the wall for our councils and indeed this jurisdiction. We owe it to the members who have gone before us not to let that happen.

We have a long list of former members in this jurisdiction. There are former members on that list waiting to be asked to come back. Show them and their families and indeed all prospects the benefits of coming back/joining--scholarships, hostel fund. member/spouse medical travel fund, free accidental death insurance benefit for them and their spouse, insurance coverage for their families from a company owned by the members and is a top rated company in North America, remembrance in daily mass at St. Mary's Church in New Haven after their passing, and the list goes on.

Students who graduated Grade 12 in June this year are an excellent source of new members. I recruited graduating Grade 12 student in early June this year. By joining they are eligible to apply for all State Scholarships. Some councils do not charge dues to these students while they attending a post-secondary institution.

Brothers, the new members are out there, we just have to connect with them and ask them to join and give them good reason to do so.

Our final draw for the incentives for the last quarter of the past Fraternal Year has taken place at the Organizational Meetings on July 22-23. I have very few Form 100s. I am sure that there are forms that I do not have. Please get them to me so that the recruiter, Grand Knight, and District Deputy can have their names in the draw.

The following is a glimpse at membership how our efforts recruitment progressing so far this Columbian year. In July and August, we have added 8 new or former members to our jurisdiction with an overall gain of 11 members. We are almost at the end of our second month of the Columbian year and I realize that many councils have not regular held monthly meetings since June. I trust that councils have been on the lookout for new or former members throughout the last 2 months and will be ready to exemplifications when your councils get started up in September. There are some exemplifications by 2-3 councils in early September and I want to encourage councils to inform other councils of the dates so that

more than one council can avail of the exemplifications.

Please continue to encourage prospects to join Online and then migrate to a council of their choice. Online is a great tool to get new members into your council. If you have any questions, please contact our Online director, Brother Gerard Butt.

Also, just a reminder to send a copy of the Form 100 for new members to Brother Maurice Lewis in order to qualify for the recruitment incentives.

I look forward to working with all of you to have a successful year in recruiting in 2023-2024. Every new or former member that we can recruit means that we are growing as an Order and we will have extra hands to help councils carry on the good works in our programs. Let's get all our councils active in recruitment for the benefit of each council in particular and the Order as a whole.

2023-2024 Membership Incentives

- 1) All proposers from July 1 to August 31, 2023 entered in a draw for \$100.
- 2) The Fraternal Year will be divided into 4 quarters—(July, August, September) (Oct., Nov., Dec.), (Jan., Feb., March), (April, May, June). For each quarter a draw for \$100 will be held for:

- a) Proposers---name entered for every member proposed
- b) Grand Knights----name entered for each member recruited in his council
- c) District Deputies---name entered for each member recruited in his district
- 3) Any proposer recruiting 10 new/former members receives \$100.
- 4) Grand Knight of a Star Council receives \$100.
- 5) District Deputy of a Star District receives \$100.

Brothers, our quota this year is 115 new/former members. We can reach this quota if everyone pulls in the same direction. Incentives work, but we all have a responsibility to let the rank and file membership know that these incentives are available.

Message from State Membership Director

Brothers, even though most of your councils have already had or will have your first regular monthly council meeting soon for the Columbian year 2023-2024, there has been a fairly high level of work taking place in regard to recruitment of new and former members. During the months of July, August, September, and our

membership has grown to almost 30 New/Former members through transfers, re-admissions, reinstatements and inviting Catholic gentleman to join our Order.

Even though we have stated many times that Recruitment is the responsibility of every member of the Knights of Columbus, all councils are not buying in to message. This is evidenced in the fact that many councils have recruited a new or former member in 5-10 years, and in some cases longer. These experiencing councils are difficulties running programs productive holding meetings. Members getting burnt out since they must do more work and take on more responsibilities. On the other hand, councils that have recruited on regular/yearly basis has seen improved programs increased enthusiasm in their councils. I feel that this resurgence in councils is due to the infusion of new ideas, new blood and new energy that comes from the presence new members.

We need to get, at least, one in each of member our councils become to the membership director of the council. If you don't feel comfortable asking/inviting a Catholic gentleman to join your council, you can pass the information on your to council's membership

director. If that fails, you can get in contact with Pat Gambin and Maurice Lewis, since we are both on the iurisdiction's membership team. If you think Brother Lewis and/or I are too shy to invite new members, then you can follow up with Brother Ray Bonia who has put a great deal of effort into recruiting in the past couple of years, especially in regards Exemplifications and follow up on the prospects through online registration. Another option is to contact Brother Gerard Butt who is wellversed in the procedures involved with becoming a member of the Knights of Columbus Online. These are some of the options that are available to anyone who wants to GROW the ORDER through recruiting.

Last year, we achieved the Circle of Honour by reaching intake goal our membership. The intake goal this Columbian year is 115 new/former members. reached our goal last year on the backs of approximately 15 out of 34 councils, which is less than 50% of councils actively recruiting and almost one-half of the total numbers resulted the online registration Process. **Iust** what imagine could we achieve if all 34 councils actively recruited members and what benefits your council, your Parish, and your community would reap, not to mention your jurisdiction and the Knights of Columbus worldwide!!

With the need for new blood and new ideas in our councils, I want to ask and every council to make recruitment of at least one member to your council this year. Everyone will benefit from this effort. I also want to encourage the councils that are already recruiting to continue to do so. They might also look at mentoring another council to show them what works for you. We can learn from each other.

On that note, let's all put a strong effort into recruitment in order to keep Blessed McGivney's mission alive for the betterment of society as a whole.

Working together, we can achieve our goals.

Message from Fourth Degree Master

Brother Knights/Sir Knights:

The Fourth Degree of the Knights of Columbus has existed in Newfoundland and Labrador for over 100 years, with the first assembly starting in St. John's in 1916. Today there are 13 active

assemblies with numbers ranging from 11 Sir Knights to 182 Sir Knights. We have a total of 874 Sir Knights on the roster, which is down 60 Sir Knights from last year. This is my fourth and final year as District Master. I have yet to visit 3 of these assemblies because they have not had any meetings.

The Fourth Degree Knights concentrate the majority of their activities on the principle of Patriotism, with Assemblies being focused throughout the year on receiving the Supreme Civic Award by conducting a minimum of four patriotic programs. Last vear, assemblies were eligible and applied for the Supreme Civic Award. Assemblies encourage and allow different members to get involved on events like July 1st, Remembrance Day, Flag Day in February, High School Speaking Competition in the spring, and so on. Most assemblies meet and continue to plan for some special event, a tribute to the spirit of patriotism and national pride. While not all Sir Knights will participate in Honor Guards, the Fourth Degree continues to provide Guards of Honor at

Mass. wakes, funerals, dedications, special church celebrations, and many other civic or patriotic functions. While there are presently approximately 25 Sir Knights with the new uniform, many Sir Knights dress with their social baldric for Memorial for Masses deceased funerals, members, Ordination anniversary Masses, Exemplifications, Installations, parades, special feast days in the church, rosaries, etc.

The Fourth Degree continues to encourage active Catholic citizenship and foster a spirit of patriotism in our members and throughout the entire community. The Fourth Degree remains motivated to be a group of outstanding Sir Knights who are dedicated to the service of their Church, their country and our Order. We had our 4th Degree AGM in April with representation from 10 assemblies.

This past year in Newfoundland and Labrador with the Relic Pilgrimage of Blessed Michael McGivney, Fourth Degree Honor Guard were quite prevalent at all Council relic events.

In the meantime, Assemblies are encouraged to recruit new members, and we expect to or have two three Exemplifications this fall. albeit small in the number of members. With exception of two or three Assemblies, the future looks optimistic and hopeful. Most Assemblies have officers in place, and presently we will have had 3 Installations of Assembly Officers.

I am thankful to the State Council, all Faithful Navigators, District Marshals, Officers, and Sir Knights across the Province for the work they are doing in each Assembly.

As we continue our journey in this new Fraternal Year, may it be for all of us, a time of moderation, spiritual discipline, renewal and growth. And may all Brother Knights and their families be inspired to new hope, happiness, prosperity, and abundance.

Message from Online Membership Chair

Worthy State Deputy, Worthy District Deputies, Worthy Grand Knights, and Brother Knights:

ONLINE MEMBERSHIP in the Knights of Columbus was introduced in 2017 to allow Catholic men to join the Knights of Columbus by completing online an application and short ceremonial. These men would then be Associate Members under the jurisdiction of the State Council of the state in which they reside. Men who entered the Order through the online initiation would be permitted to purchase insurance, even though they have not taken the First Degree, and the Supreme Secretary would issue membership card to the new Brother Knights.

Every state council is authorized to accept members through the online membership initiative. The Supreme Council office administers the state divisions, including the collection of dues and the membership issuance of cards.

Men who join the Order through the online membership initiative do not form a new class or type of member. Therefore, members of the Knights of Columbus they are entitled to the rights and privileges of membership, which include being eligible: to attend local, state, and Supreme Council events, to attend local council meetings as nonvoting participants, to receive fraternal benefits, to purchase Knights of Columbus financial products and services, and to receive the

Columbia magazine and other Supreme Council publications.

Men who join the Order online are encouraged to attend local council business meetings, and encouraged to become members of that council.

So far this year, 10 new members have joined online in NL. Last year we had an all-time high of 52 members joining online. Our all-time intake for Online Membership is 125, with 48% of these so far converting or migrating to a local Council.


Fr. Michael McGivney Relic




Our Lady of Assumption Council Report
