It is important that voting Delegates follow the instructions on how to vote. The voting will be anonymous. The system that we are using records the votes but does not show how any particular Delegate voted. Remember that only credentialed Delegates have the rights to vote, and to speak, and they must be recognized to speak. If someone with the right to speak wishes to do so, please hit *3 on your phone, and you will be placed in the queue. Note that you may be contacted so that we may know your intention to alert me when to recognize you. Please do not mute your phone.

Even though we are using an electronic polling system for the vote, in case of an unforeseen issue, I have appointed **Michael Tobin**, past state deputy as the judge and the following past State Deputies, **Emile Cabot** and **Maurice Lewis** as tellers.

Nominations will cease automatically after three calls, and if there are no other nominations, the State Secretary will cast one ballot for the person nominated for the specific state position for a one-year term commencing July 1, 2020. Should there be more than one nomination for an officer position, a vote will be held, and when completed the State Secretary will announce the number of ballots cast, and to which candidate the majority of votes went. The number of votes for each candidate will not be disclosed.

Bio for Gordon Lannon – Nominee for State Deputy

Leo Gordon Lannon is a retired journalist. He spent 33 years with C B C Radio News working in Eastern, Central and Western Newfoundland

Gordon has been a volunteer with, and a leader of, many different organizations. He was an executive member of the Lions Club in Harbour Grace, organized and served as the leader of a Scout Group in Clarenville, coached minor softball and minor curling, and served as an executive member of Senior Softball, Senior Curling and the Golf Association in Clarenville,

In addition to his civic and volunteer work, Gordon is also active in his church and with the Knights of Columbus. Gordon has served as Chairperson of the Parish Council at Holy Rosary Parish in Pasadena and continues to be a lay reader and Church Usher.

In 1984 Gordon joined the Knights of Columbus as a Charter member of Our Lady of Fatima Council in Clarenville, and then in 1986, he became a Fourth Degree Member.

In 1999, after re-locating to the West Coast of the province Gordon became a member of Archbishop Neil McNeil Council # 8555 in Pasadena

Gordon has served on the Executive of Archbishop Neil MacNeil Council since 1999 and has filled many of the positions on the executive including Recorder, Chancellor, Deputy Grand Knight, and two terms as Grand Knight. In 2012 Gordon was elected Faithful Navigator with Bishop O'Reilly Assembly 0624, and served two years as FN.

In 2013 Gordon was elected to the State Council and has served on the State Board as State Warden, State Advocate, State Treasurer, and State Secretary.

Gordon is married to Margaret Fitzpatrick and they have three children.

Bio for Pat Gambin – Nominee for State Secretary

Pat is retired after teaching for over 30 years. During his career as a teacher he taught in most areas of Newfoundland and Labrador with 25 years in Labrador. He retired in 2003. He presently holds the position of State Secretary, a position to which he was elected at last year's State Convention in Gander.

Pat took an active part in community life in each community where he worked by being involved with the Church, recreation groups, fundraising groups at the local and provincial levels, such as the Heart and Stroke foundation, Cancer society, and the Kidney foundation.

At the school level Pat was active with coaching school teams such as hockey, soccer, volleyball, gymnastics and especially wrestling which he has coached since 1972. He has wrestled with and coached provincial wrestling teams at the national level.

Pat joined the Knights of Columbus in 1986 at Bishop Scheffer Council in Happy Valley–Goose Bay where he served in many different positions, for 20 years, including Grand Knight for 2 years and Membership Director of the Council for most of his tenure. He was appointed to the State Board as District Deputy for Labrador in 2001. He served in that capacity for 4 years until 2005 and in May 2005 he was elected State Warden for our jurisdiction of Newfoundland and Labrador. He was re-elected to the position of State Warden the following Columbian year. In 2006 Pat moved to McIvers on the north shore of the Bay of Islands where he transferred his membership to Archbishop Howley #2581 in Corner Brook. In 2007, Pat was elected as State Advocate and served in that position for the year 2007-08. Due to family commitments, Pat resigned from the position of State Advocate in June 2008 to take up a teaching position in the Northwest Territories.

After returning from the Northwest Territories, Pat was appointed to the position of Membership Director and in 2015 he was elected to the position of State Warden (AGAIN) which he held for 2 years before being elected to the position of State Treasurer in 2017and again in 2018. Pat has served as State Membership Director for 7 years, a position he presently holds. He is still actively involved in his home council in Corner Brook where he is the council's Lottery chairman, membership director and youth director.

Pat is still very active in sports, his Church and other community activities. He plays ice hockey 3-4 times a week and teaches Newfoundland/Irish square dancing on occasions at some schools in the Bay of Islands area.

Pat lives in McIvers in the Bay of Islands, on the west coast of the Island approximately 35 kilometers from his home council. In spite of the distance he attends general meetings on a regular basis and participates in most council functions.

He has 3 children with his wife, Delores and are the proud grandparents of one grand daughter age 10and two grandsons ages 8 and 11.

Bio for Gary Gallagher – Nominee for State Treasurer

Brother Gary Gallagher has been a member of the order since April of 1986, He has held many positions in his council including four years as Grand Knight of Council 9303, three years as District Deputy and has served on the NL State Board in the positions of State Warden, State Advocate and since July 2019 has served as State Treasurer.

Brother Gallagher is retired from Bell Aliant where he worked for Thirty-Four years. He holds a diploma in Electrical Technology from CONA. His primary responsibilities at Bell Aliant were as a manager in technical operations. Since his retirement some 14 years ago he and his partner have established their own company and currently do limited contractual assignments throughout the Caribbean specializing in DC Power and telecommunication services.

Besides being a member of this great organization he is a long-time member of the Telephone Pioneers Association of America with the Fort Pepperell Club and assists at many of their functions throughout the year. In 1985 Brother Gallagher spearheaded a group of local parishioners and then co-chaired the building committee which constructed the current St. Thomas of Villanova Church located in Manuels, Conception Bay South.

In 1995 he joined the Manuels River Natural Heritage Society in Conception Bay South. He rose to position as Chair of the Board of Directors of the Society. Realizing new space was needed to operate the Society and expand its goals he again spearheaded a project to build a new Centre. He along with a Co-Chair led a community group of volunteers and undertook and oversaw the construction of the new Manuels River Hibernia Interpretation Centre. A building which has now become the center piece of the Conception Bay South community activities in the town. In 2012 he was awarded the Harris Fellow Award, Rotary's highest honor, from the Rotary Club of Avalon Northeast for his work on the new Centre. He retired from the Board of Manuels River in February of 2013.

Brother Gallagher devotes considerable time to his parish and has been a constant member of the church choir at St. Thomas of Villanova for over 30 years. He serves in his own Council as Advocate and is a Fourth Degree

member of Archbishop Howley Assembly in St. John's. He and his wife Sheila reside in Conception Bay South and they have three sons and one granddaughter all of whom reside in the St. John's Conception Bay South area.
