Chili powders, such as Gephardt, Adams, etc. are permitted. (NO Chili Kits such as Two Alarm or any others allowed) All chili must be started from scratch and cooked on-site. No beans or fillers may be added to the chili. (All ingredients are to be prepared on site). Teams will be limited to the Head Cook and three (3) team Members.

All cooks must supply their meat, cooking utensils, cooking table and cooking devices. Cook stove must be in good working order. Only portable cook stoves may be used. Each team may bring a 10x10 pop up tent for their space.

Registration fee is \$50.00 per team.

Turn-in time for chili will be 1:00 pm. Cooks will be allowed to set up beginning at 7:00 am on Saturday April 2nd,2022 (No vehicles allowed after 8:00 am) Two (2) places (first and second) will be awarded. A showmanship trophy will be awarded (example = decorations, skits, costumes, etc.) There will be a People's Choice award given to the team who receives the most tickets collected from the People's Choice Taster cups.
