# **Privacy Policy**

("The Company") and governs data collection and usage. The Company's websites are an accounting and financial subscription (monthly) and one-time fee websites. These services can be cancelled at any time. By using the Company websites, you consent to the data practices described in this statement.

### **Collection of your Personal Information**

In order to better provide you with products and services offered, the Company may collect personally identifiable information, such as your:

# **Use of your Personal Information**

## **Sharing Information with Third Parties**
