- Preference will be given to students registered to vote, or who plan to register when they turn 17. If you provide us your voter card, block out your party affiliation as it is irrelevant.
- **APPLICATIONS MUST BE RECEIVED BY EMAIL ON OR BEFORE TUESDAY, MARCH 17, 2026. LATE OR INCOMPLETE APPLICATIONS WILL NOT BE ACCEPTED.**
