



### **WOODRIDGE SWIM CLUB GUEST LIABILITY WAIVER**

To the maximum extent allowed by law, I, the undersigned agree to waive and release any and all claims, suits, or related causes of action against Woodridge Swim Club, its officers and employees (collectively "WSC"), for negligence, injury, or loss, death, costs, or other damages to me, my heirs or assigns, while on the premises of WSC.

In consideration of being allowed to utilize WSC's facilities, I agree I will assume the risk and full responsibility for any and all injuries, losses, death, costs or other damages, that might occur to me and/or my family while on the premises of WSC.

I agree I will indemnify, defend and hold WSC harmless, to the maximum extent allowed by law, from negligence, injury, loss, death, costs or other damages to me, my heirs or assigns, or third parties for claims, suits, or related causes of action asserted against WSC arising from my conduct and/or my family's conduct while on the premises of WSC.

I agree this Waiver and Release of Liability ("Release") shall apply to each visit I make to WSC, including future visits, regardless of any date visited during the current Membership season, and regardless of the date that this form is signed below. I agree to, and will comply with, WSC's Code of Conduct. I acknowledge WSC's policies are subject to change at the sole discretion of WSC.

This Release shall bind the members of my family, and my spouse or registered domestic partner, if I am alive, and my estate, family, heirs, administrators, personal representatives or assigns if I am deceased and shall be deemed a "Release, Waiver, Discharge and Covenant" not to sue WSC.

I agree this Release is intended to be an enforceable release of liability and indemnity as broad and inclusive as is permitted by Washington law. I agree that if any portion or provision of this Release is found to be invalid or unenforceable, then the remainder will continue in full force and effect and any invalid portion will be modified or partially enforced to the maximum extent permitted by law to carry out the intention of this Release.

This Release is governed by and shall be construed in accordance with the laws of the state of Washington, without any reference to its choice of law rules. I agree that any dispute arising from this Release or in any way associated with WSC shall be brought only in the Superior Court of King County, Washington, or in the U. S. District Court for the Western District of Washington,

and I agree to the jurisdiction and venue of those courts for any such dispute. In any litigation in which the validity of enforceability of this Release is contested, I agree that the substantially prevailing party will be entitled to receive all attorney's fees and costs from the party contesting the validity of this Release.

This Release, in conjunction with the Guest Code of Conduct Agreement, encompasses the entire agreement of the parties, and supercedes all previous understandings and agreements between the parties, whether oral or written. I acknowledge that no oral representations, statements or other inducements to sign this Release have been made apart from what is contained in this document.
