In the fall of the year, my car was repossessed. I spent \$400 per week on transportation getting to and from school because I did not have access to a car. It was extremely difficult to get around with three children, especially when it came to my children's games and practices. HOPE stepped in to offer Lyft rides through their partnership with Heirborn, but I still struggled to financially keep up with the added expenses. I lost three job offers due to no transportation. HOPE saw my need and helped me get approved for a car gift from Heirborn. They assisted me with the down payment and my first two months of insurance payments. Two days before Thanksgiving, my children and I received a Chevrolet, solving my financial issues. I was able to get a higher paying job and cover my family's needs. I am SO grateful to HOPE and the HOPE family of donors for supporting this great mission.

TRANSFORMED 348 LIVES IN THE PAST 14 YEARS!

Through your contributions, we have been able to help 115 single parents, including our current participants, and 233 children.

In 2023, you made sure that 28 single parents and 65 children received the support they needed. In fact, 15 single parents graduated with their degrees! OUTSTANDING!

This remarkable success stands as a testament to your impactful support, which has been instrumental in fostering financial resilience and self-sufficiency among these dedicated families.

MEET ERICA

Meet Erica, a 41-year-old mother of three with a dream of becoming a nurse. When Erica was accepted into Chamberlain University's nursing program, she quickly discovered that it was very difficult to keep up with the financial obligations and day-to-day responsibilities of managing a home. She started to wonder if it was possible to pursue her dream of becoming a nurse without putting her children's dreams and aspirations on hold.

Then, Erica received an email from her university about H.O.P.E. Inc.'s program. She applied for the program's financial assistance and was accepted as a participant. For her, she was accepted into the H.O.P.E. program during a time she needed it the most.

"It was a time when I wanted to give up, and I didn't know if I was going to make it through nursing school," Erica says. "And yet, I could always call H.O.P.E., and they were always there for me. Whether it was just to talk or to offer advice or encouragement, they were the outside support when you can't go to your family."

H.O.P.E. Inc. provided Erica with financial assistance for her monthly mortgage payments. However, the

support did not stop there. H.O.P.E. also offered additional resources, such as a personal financial coach, budgeting classes, counseling, and life coaching that helped Erica prepare for life post-grad.

"I was previously living paycheck-to-paycheck and would get behind on things to pay something else off," she says. "H.O.P.E. helped me get on track and get my emergency fund together. Now that I've finished school, I'll be going into a different income bracket. They taught me how to budget and maintain it."

H.O.P.E. also helped when it came to supporting Erica's children. During holidays, they would provide gifts off the children's wish lists, and they also helped buy school supplies when the kids went back to school. When Erica's oldest son was injured and couldn't play football in college, H.O.P.E. offered him a scholarship so that he could get the supplies he needed for school.

On August 25, 2023, Erica graduated from Chamberlain's nursing school, and now she is lined up to start her new career working in an emergency room department in November. ■

OVERALL IMPACT CTD.

We are thrilled to share the incredible results of our recent survey of our graduates, taken in February 2024. An impressive **74%** of our graduates responded, providing invaluable data on the impact of our program over the past thirteen years.

The data speaks for itself.

97% of our graduates are currently working in their chosen career field and living above living wage!


Nearly half **(46%)** of our graduates are the first member of their family to attend and graduate from college, breaking the cycle of intergenerational poverty.

A staggering **82%** of our graduates have experienced a significant increase in their yearly incomes, roughly **\$38,923** more! 17% of them now earning between **\$40k-\$50k** and 66% earning between **\$40k-\$50k**.

Even more exciting is that **37%** of our graduates had no savings when starting our program, but now **89%** of our graduates have established savings accounts since completing our program, with an average balance total of **\$2,615**, a **219%** increase.

Finally, we are proud to report that our graduates have made incredible strides in improving their credit scores. From an average score of **596** when they started our program, their scores now average **638** or greater, a **42-point** average credit score change.

These results are a testament to the transformative impact of our program, and we are incredibly grateful for the support of our donors and partners who make this work possible. Thank you for joining us in creating a brighter future for all. We are humbled and inspired by the incredible impact you have been able to make in the lives of single parents across multiple counties.





PROGRAM IMPACT

Academics

With an average of one year and one month in the program, our current participants have shown validated growth. 100% of our program participants are on track to graduate on time, less than a six-year timeframe, as stated and encouraged in our goals. They have maintained an average GPA higher than 3.44.

25% pursued an Academic Associates (AA) degree, the remaining

75% pursued a Bachelor of Arts or Bachelor of Science (BA/BS) degree

We've always felt that our program could be replicated in other major cities with high single parent populations and colleges to support them. Birmingham as a 65% single parent population, 3rd in the country. We are excited to serve them, starting with the students at Lawson State Community College.

MEET AARYONA

Prior to being accepted into the HOPE Program, she had been evicted and was living in and out of her car with her two-year-old son. As a full-time student, she was only able to work part-time which provided her with limited income. Most of the time, she could not afford daycare, gas for her car, and even food. Every month she found herself choosing between paying her car note or paying her rent. With the increase in the cost of living, she was unable to afford both payments. This resulted in an eviction and led to her homelessness.

To get out of this cycle, she had to find stable affordable housing and secure a full-time job. We partnered with the House of Dawn and was able to secure housing for her. We assisted with her first month's rent down and purchased a \$100 gas card and a few \$250 grocery cards to help her as she transitioned into her new living situation. We also provided her with mental health services and life coaching to help her break the cycle and reach her goals.

SAVINGS & FINANCIAL STABILITY

Before starting our program, **44%** of our participants did not have a savings account. Now, **80%** of them do, with **25%** over **\$1,000**.



Currently, **94%** of our participants improved their credit scores by at least **100** points since beginning the program.

13% of our participants own their own home already.
