

We have always tried to make our convention engaging and entertaining. We always try and mix education with action, and offer a space for us to commiserate safely. Our sessions are long and busy as there is a lot to cover. Our speakers and panels are dynamic and bring a depth of information and perspective to the issues affecting us. It is my hope that we will be able to build bonds while challenging our minds. To break bread while strengthening our skills and resolve. Welcome CBTU family and friends. I missed you all.



COVID RULES

Due to the on-going COVID-19 concerns, the following procedures are mandatory before proceeding to the registration area & participating in any Convention activities:

- 1. A Sergeant-at-Arms will verify your vaccination status before you will be allowed to proceed to obtain credentials at the registration area.
- 2. You must go to the registration area to obtain a badge before proceeding to your booth space, training room or convention hall.
- 3. The badge must be worn at all times as it confirms you have met the vaccine requirement.
- 4.These are the policies mutually agreed upon between CBTU & the Westin Bonaventure Hotel.
- 5.Non-compliance will result in immediate removal from all convention activities and venues.
- 6.If removed from venue no refunds will be given.



RULES & ORDER of BUSINESS

Rule 1	The meeting of the Coalition of Black Trade Unionists shall be called to order as outlined in the agenda.
Rule 2	All cell phones are to be turned OFF during all sessions of this convention. The Sergeant-at-Arms will collect \$50.00 from you if your phone goes off during any session.
Rule 3	Before a delegate is granted the floor, they shall proceed to the nearest microphone and, before expressing their views, shall make known their name and/or chapter/city they represent.
Rule 4	No question shall be subject to debate until it has been made, seconded and stated from the chair.
Rule 5	If a delegate is called to order while speaking, they shall, at the request of the chair, take their seat until the question of order is decided.
Rule 6	Should 2 or more delegates rise to speak at the same time, the chair shall decide which delegate is entitled to the floor. This decision is not subject to appeal.
Rule 7	No delegate shall interrupt another delegate in their remarks, except to raise a point of privilege. The chair shall determine with the advice of the parliamentarian whether the point raised is a question of privilege. An appeal from the decision of the chair shall not be entertained unless it has support of 25% of the present voting delegates.
Rule 8	Speeches on matters of business shall be limited to 5 minutes, however time may be extended by majority vote of the delegates present and voting.
Rule 9	A delegate may not speak a second time upon the same question until all delegates wishing to speak have had an opportunity to do so.
Rule 10	The chair with the approval of the Executive Council shall ap-point the following committees: Constitution, Credentials, Resolutions, Rules, and Sergeant-at-Arms
Rule 11	Robert's Rules of Order, revised, shall be the guide in all cases in which they are applicable.



ELECTION RULES

Rule 1	The election of officers and council members shall be conducted under the supervision of the Election Committee, which shall have the authority to prepare ballots, appoint registration clerks, tally the votes cast for all candidates and certify the results of the voting for the Committee's report to the Convention.
Rule 2	All of the officers, 38 At-Large members of the Executive Council and 8 Trustees are to be elected to a 4-year term.
Rule 3	To be eligible for election a nominee must be a member in good standing of CBTU.
Rule 4	No member of the Election Committee may be a candidate for office.
Rule 5	Any candidate whose name is to appear on the ballot shall have the right to have present an official oberserver chosen by the candidate in all places where ballots bearing the candidate's name are to be cast and counted. Observer's name must be submitted to the Election Committee prior to election. NO candidate may serve as an observer.
Rule 6	If there is only 1 nominee for any office or if all nominees except one decline, the nominee shall be declared elected. In all other circumstances, the election shall be conducted by written secret ballot, and the names of the candidates shall appear on the ballot in order of their nomination.
Rule 7	The candidate receiving the greatest number of votes shall be elected.
Rule 8	Polling booths shall open 2 1/2 hours following the business session on Saturday. At the time of closing, all delegates in line who have not had an opportunity to cast their ballots shall be given an opportunity to vote.
Rule 9	Any challenge regarding eligibility of any candidate or of any delegate appearing to vote and any protest regarding the conduct of the election shall be referred to the Election Committee, which, after conducting a hearing on such challenge shall make a decision and report to the Convention.
Rule 10	The nomination and election of officers shall be conducted in accordance with the elections rules set forth berein.
Rule 11	To be eligible to vote a member must be credentialed and seated as a delegate.






