Also...

A reminder to everyone about the first phase of truck number changes happening on Saturday, January 1st, 2022, at 07:00. Phase one will essentially eliminate all three-digit numbers with a "zero" in the middle. Chief officers, the duty officer, and the flatbed Ford are affected. The transition will happen as follows:

Chief moves from 800 to 8800

Deputy Chief moves from 801 to 8801

Deputy Chief/fire marshal moves from 805 to 8805

Flatbed Ford moves from 808 to 8802 or 819 depending on use. If this truck is being used for utility it is 819, if it's being used for duty officer, then 8802.

The remainder of the fleet will change later in 2022.

A Grim Reminder

From an email sent out by Chief Lewis and Fire Marshal Corey Rice

On December 22nd, Boone County Fire Protection District saw the horrific results of what most in Emergency Services know sadly to be a sobering reality. They suffered a Line of Duty Death involving one of their firefighters and an incident on the highway. This serves to remind us to always be vigilant. Be aware of your surroundings at all times. We want to limit our exposure time on the highway as much as possible. More is not always better, so we need to use discretion about how many trucks we put out there. We should only send what's absolutely needed and minimize our risk. After EMS clears the scene, we should return and leave traffic control to law enforcement as we cause more of a traffic problem the more trucks we have on the highway. We have already had two trucks hit on the highway. Please take time to review proper lane blockage for vehicle accidents.
