## Sunday, 10/4/2020

All in attendance.. (Keri Jockers, Kathy Bennetto, Jeff Brodersen, Denny Duryea, Rich Marino,, Dave Sachitella, Dave D'anna, Rosario Savastra, Nancy Wilson)

Jeff asked what else we need to do today other than plan for next year.

Kathy said we were supposed to go over the budget before voting on it.

Contingency fund - \$7600 - in the checking account, we have \$26,442 total. We're putting \$10,000 in the contingency fund.

Jeff to close the beach - maybe \$1000 or \$1500.

Street light in front of clubhouse does not have to be replaced. We own it so that will be the only bill we'll be getting every month over the winter.

(we are nonprofit)

Rich Pinder did work on wall in 2018, he's not responding to calls to do an inspection. He hasn't done an inspection at all since he fixed the wall. He's under contract. 203-996-4492

Kathy got a call about a chunk of cement - looked like a buoy - on Hartford Avenue. Needs to be taken away. Rosario said he'll take it.

On proxies, going forward we should have a line for address and printed name. (Keri will type up a new one)

Today, we have to establish who is in charge of what before the winter.

Nancy suggested that any new members get a welcome letter, a copy of bylaws, spring letter, copy of rules, etc. Tell association members that rent their houses out that they have to post their rules in their cottage where renters will see them and understand them. Dave D'anna said he's in real estate, so he can check in on new closings in the area so we know who's new to the association. They also said we should send out the lanyards to new members.

According to Kathy, from 10:00-4:00 chain to boat ramp is supposed to be locked on Saturday and Sunday. Jeff said it's not on the insurance policy.

Dave D'anna is going to keep the lock - lock it at 10am and unlock at 4:00pm on Saturdays, Sundays, and holidays.

We should start making sure that renters are given a list of the rules so they know - and, everyone should start bringing their lanyards to the beach. All board members and members should take it upon themselves to let people know when they're violating a rule.

Keri will call harbor master about a "no wake" sign.

Jeff said we still don't have a Covid sign on the Hartford Avenue side. They're still on the Middletown Avenue beach, so we'll wait and see if they get picked up. If a storm comes, Nancy said she'll fold up the signs and get them out of the way.

Rosario asked if we can buy 2 rakes - one for Middletown Ave, one for Hartford Ave so we can clean up when needed.

Rosario is going to work on getting quotes for a sign.
