**DIRECTIONS TO RANGE:** TWO BLOCKS EAST OF INTERSECTION OF US HWY 10 & U.S. 71, TURN EAST ON COUNTRY RD 4 & PROCEED EAST 1 3/4 MILES, TURN NORTH ON FIRST RD (SIGN ON CORNER FOR KNOB HILL) FOR ½ MILE, THEN EAST ½ MILE TO RANGE. THE ROAD WILL CHANGE FROM TAR TO GRAVEL.
