

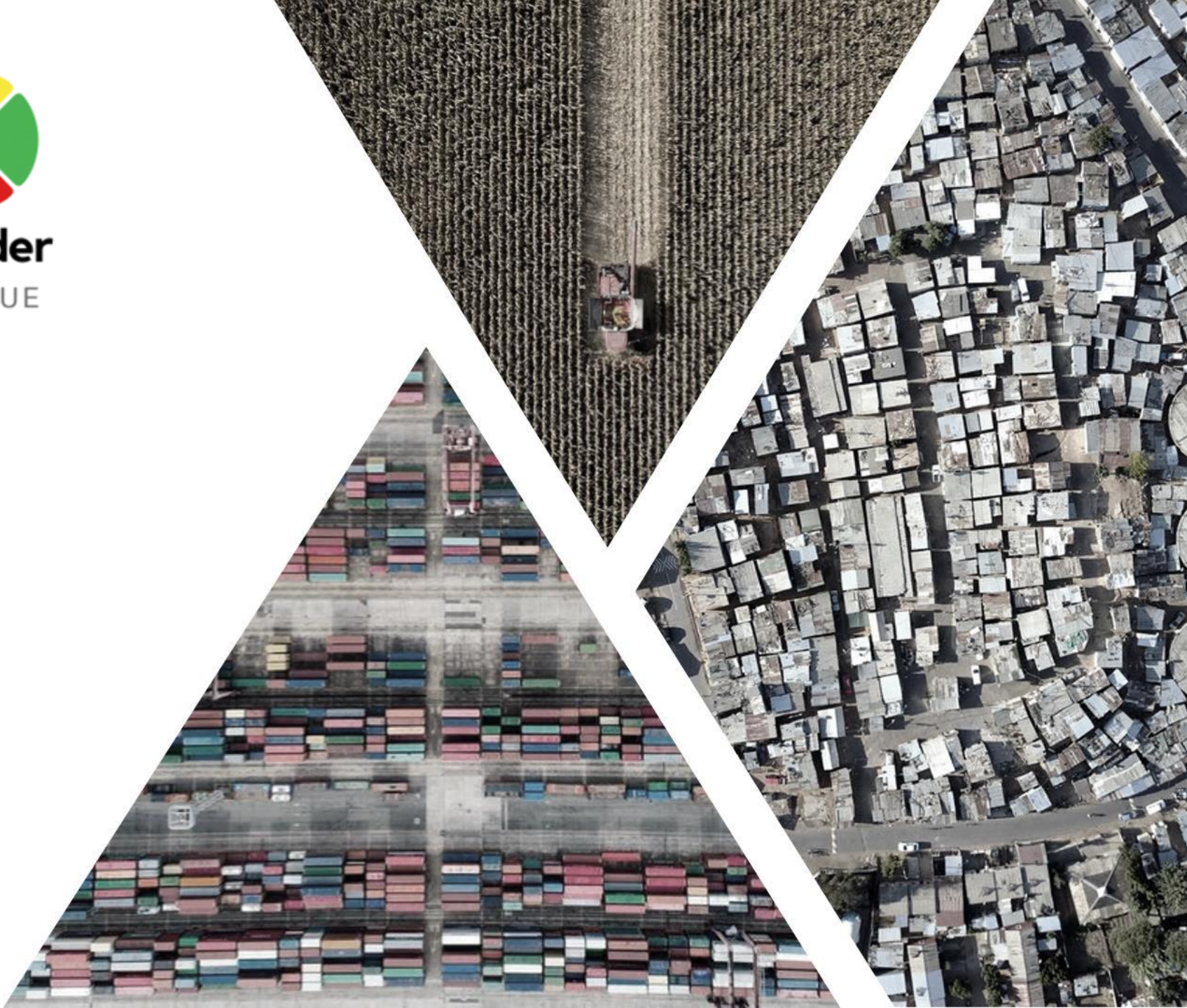

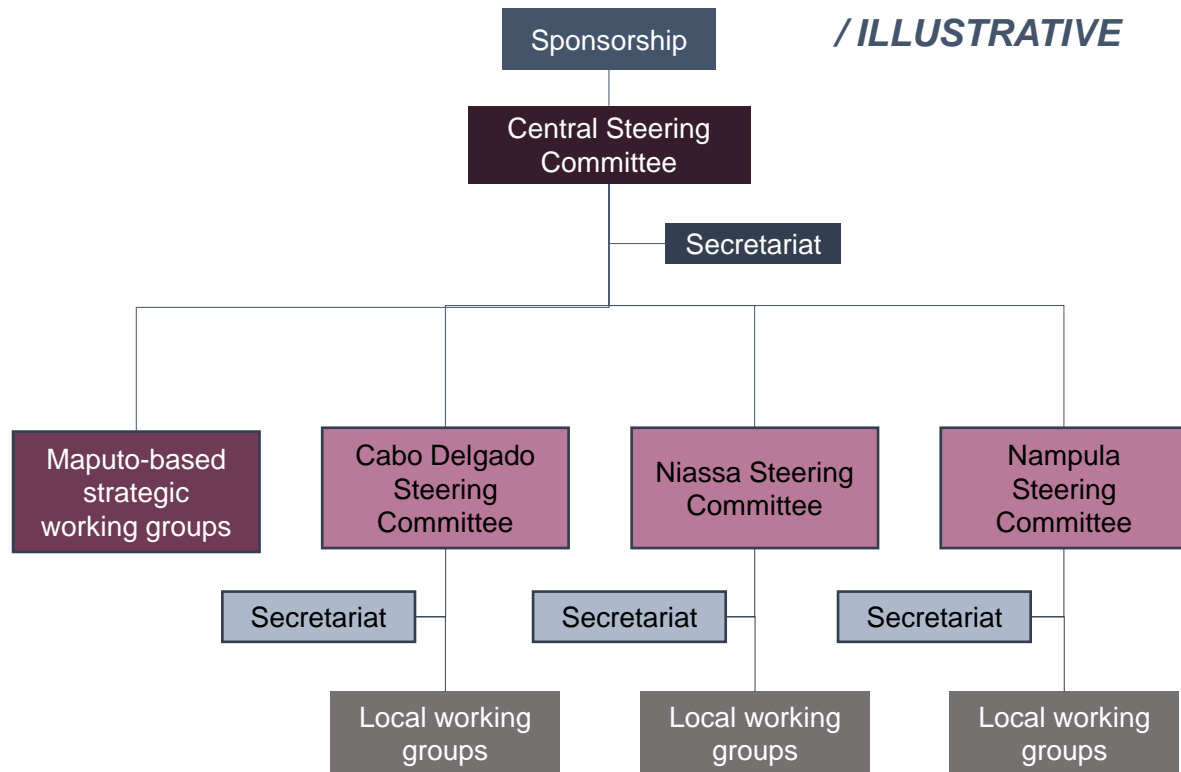

The MSP is reassessing its governance structure to accommodate for future growth and GoM vision for coordination in the North

Long-term governance structure of the MSP...



... is being coordinated with key stakeholders

- **ADIN:** one of the primary strategic pillars of ADIN's mandate will be coordination of development efforts in Northern Mozambique. The MSP has ongoing coordination with ADIN to determine their role in MSP governance.
- **Government of Cabo Delgado:** members of the governor's cabinet have been named as central points of contact for working groups with Dario Passo (Director Provincial do Plano e Finanças) as the coordinator
- **PPDS-CD:** currently negotiating collaboration between the MSP's strategic working groups and the 10 community-based working groups of the PPDS that focus on natural resource management

In the interest of improving stakeholder engagement, the program is supporting the costs associated with the current phase of MSP secretariat as a bridge to a more secure, long-term funding structure.

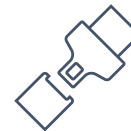

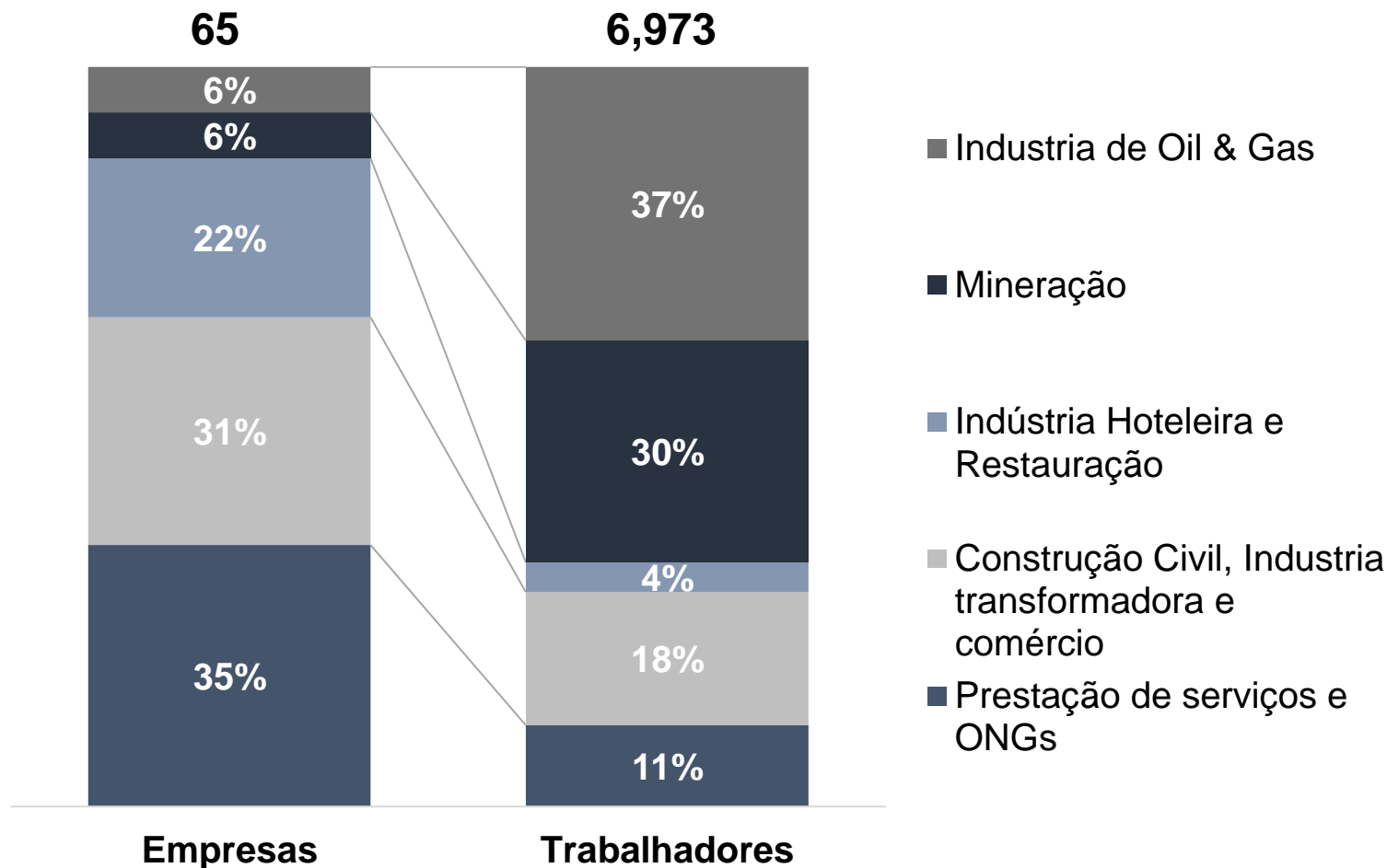

O setor privado em CD encontra-se fortemente fragilizado devido a uma serie de acontecimentos



A 11 de Junho de 2020, o CEP CD registou o fecho de 65 empresas e a rescisão de quase 7 mil contratos

- A maior parte dos **empregos perdidos** neste periodo observam-se no setor do **Oil & Gas**
- **Empresas provedoras de serviços e construtoras** constituem a maior parte das empresas a fechar
- É possível ainda que o número de Empresas e trabalhadores afetados seja superior ao acima apresentado.



Para assegurar um futuro melhor, é necessário investir social e economicamente no desenvolvimento da província

1. Complementar combate à insurgência com **investimento na geração de emprego**, fortalecendo a juventude contra o recrutamento
2. Criar condições favoráveis para o **financiamento de PMEs**, nomeadamente relativamente às taxas de juros e prazos de reembolso
3. Operacionalizar competentemente **infraestruturas existentes** (Portos comerciais e bases logísticas da província) e **investir em obras estruturais** (como vias de acesso)
4. Alavancar a atividade económica dos projetos GNL para o **crescimento do conteúdo local**
5. **Fortalecer corredores de desenvolvimento para assegurar o crescimento da região inteira** (ex.: criar rede de acessos com a província do Niassa para uma maior utilização dos portos de Pemba para exportação)
