Other points of interest we are working on include: point of sale software and implementing online Tee-Times, we will continue with our food phone line for take-out orders and providing a clean, family-oriented place to enjoy.

The FAMILY UP & DOWN category has been a huge addition to our golf family the past two years and we will continue with it going forward. Purchase the Family Up & Down; it includes your parents, grandparents, your kids, spouses, and your grandkids, all in one annual pass price of \$1,400.00 tax included! The primary purchaser must be an active golfer. Send me an email if you have any questions on the annual passes.

Again, this year we will be offering the opportunity to pay on a monthly basis through automatic withdrawals. We ask for 25% down and then the remainder of the balance will be taken in 10 even monthly increments (if started in February) and will be paid in full in November. This can be started in any month and will be calculated out to be paid in full to November. Again, just send me an email if this interests you or have questions.

With the early payment of an annual pass, we will be offering a credit inside the clubhouse if fully paid by **February 15, 2021.** A \$50.00 credit for couples or a \$30.00 credit for an individual will be available. The credit will be in the form of a gift card with no expiration date and good for anything in the clubhouse at any time. All prices listed include the 7.375% sales tax. We will continue with our January gift card drawing this year; if your annual pass is paid in full in January, your name will be put in a drawing for \$50.00 worth of gift cards, \$25.00 at the Leaf Valley Mercantile and \$25.00 at The DogHouse Bar & Grill in Parkers. So, for a chance at \$50.00 worth of gift Cards, return your application this month! Louise & Steve Cook were the lucky winners last January.

We hope to see you back out on the course this spring and start enjoying outdoor activities again, this year right away when the course is ready. Our average start date over the last 25 years is April 9th, it's less than 100 days away, let's all hope its sooner than later. 2021 Automatic Debit Agreement

I understand that I am purchasing a 2021 annual pass that is being paid for over 10-month calendar that begins February 15, 2021 continuing through November 15, 2021.

- Automatic debit withdrawals will be made on the 15th of each month.
- All written debit authorization must provide that the Receiver may revoke the authorization only by notifying the originator in the manner specified by the Receiver.
- Single entry reversals do not require authorization by the Receiver.
- The underlined language in the authorization above represents the disclosure agreement requirement associated with the classifications of OFAC economic sanction policies upon ACH Network participants.
- All NSF transactions are subject to a \$35.00 service charge.

2021 Annual Golf Car Lease Agreement Lake Miltona Golf Club

- 1. There is a maximum of two persons, two bags per car. All golf car operators must have a valid driver's license.
- 2. Leases are limited to 18 holes per day, a \$7 fee is required for additional play that day.
- 3. Personal alcohol on the course or in the clubhouse is not permitted and is also against Minnesota state law (Minnesota State Statutes 340A.101 Subd. 15). All alcoholic products must be purchased on property. If we do not currently stock your favorite selection(s) let us know and we do our best to acquire it.
- 4. Driving of golf cars is a big contributor to turf wear and tear. The maximum number of golf cars allowed per group is as follows: 3 cars for a fivesome, 2 cars for a foursome, 2 cars for a threesome, 1 car for a twosome. (Spectators may ride if they have paid the rider golf car fee.)
- 5. All four car tires must remain on the paths when provided (or designated areas if no path exist):
 - 30 feet around tees please keep off tee boxes
 - Again 30 feet from greens that is 10 big steps
 - Always obey signs they're there to avoid turf damage
 - Keep out of roped and staked areas they're not there to create an obstacle course for you.
 - Steer clear of standing water in the fairway and rough when condition is wet.
 - For safety reasons, we strongly discourage the use of golf car on any slopes around greens but especially 1, 3, 6, 7, 8 & 13 greens which is also within 30 feet.
 - Do not drive in or through tall grass area. natural, un-mowed areas may be designated as environmentally sensitive, please avoided these areas.
 - On holes designated "cart path only."
 - To speed up play for the players behind you when parking by the green park 30 feet away from the green closet to the next tee.
- 6. Golf cars are not permitted on top of the practice tee.
- 7. Golf cars are not permitted off golf course property.
- 8. Golf cars operators are responsible for any damage caused to the golf course or golf car.
- 9. Violations of any of policy may result in suspension of golf car privileges.
