Happy New Year everyone!

We hope this letter finds you in good health as we enter 2022! Again, this year the pandemic has continued to renew an interest in golf and we continue to welcomed new friends into our golf family at the course. **THANK YOU** for the support this past year as well as over the years. We have established a strong foundation of members and friends that has enabled us to keep making improvements to the course and clubhouse.

We continued with the deep tine aerification of the greens. Doing this in October, after we closed using smaller tines but to the same 9" depth and applying an amazing amount of greens mix back onto the greens. We purchased a Mini-X excavator and added a second tee mower to the equipment inventory. The Mini-X will be used to clean up edges around the ponds and some bunker work. Now that the course is covered in snow we have moved inside to concentrate on improving the look and function of the clubhouse.

With the early payment of an annual pass, we will be offering a credit inside the clubhouse if fully paid by **February 28, 2022**. A \$50.00 credit for couples or a \$30.00 credit for an individual will be available. The credit will be in the form of a gift card with no expiration date and good for anything in the clubhouse at any time.

We will continue with our January gift card drawing this year; if your annual pass is paid in full in January, your name will be put in a drawing for \$50.00 worth of gift cards, \$25.00 at the Leaf Valley Mercantile and \$25.00 at The DogHouse Bar & Grill in Parkers. So, for a chance at \$50.00 worth of gift Cards, return your application this month! **Ryan Bremmer** was the lucky winner last January.

The FAMILY UP & DOWN category has been a huge addition to our golf family the past three years and we will continue with it going forward. Purchase the Family Up & Down; it includes your parents, grandparents, your kids, spouses, and your grandkids, all in one annual pass price of \$1,568.00 tax included! The primary purchaser must be an active golfer. Send me an email if you have any questions on the annual passes.

A popular way to purchase an annual pass is through automatic withdrawal, we offer the opportunity to pay on a monthly basis beginning in February and running through November. We ask for 25% down and then the remainder of the balance will be taken in 10 even monthly increments (if started in February) and will be paid in full in November. This can be started in any month and will be calculated out to be paid in full to November. Again, just send me an email if this interests you or have questions. We hope to see you back out on the course this spring and continue enjoying outdoor activities. Our average start date over the last 26 years is 8th of April, it's less than 100 days away, let's all hope its sooner than later. 2022 Automatic Debit Agreement

I understand that I am purchasing a 2022 annual pass that is being paid for over 10-month calendar that begins February 15, 2022 continuing through November 15, 2022.

Further, I understand that a single payment is due up front for the number of months due before the automatic debit will begin. Example, if auto debit begins April, then February and March dues must be paid up front. Agreement must be completed by the 10th of the month to be processed for that month.
