2024 Automatic Debit Agreement

I understand that I am purchasing a 2024 annual pass that is being paid for over 8-month calendar that begins March 15, 2024 continuing through October 15, 2024.

Further, I understand that a single payment is due up front for the number of months due before the automatic debit will begin. Example, if auto debit begins June, then March and April dues must be paid up front. Agreement must be completed by the 10th of the month to be processed for that month.
