



## TERMS AND CONDITIONS

When hiring any Tiny Tipi Co. goods, products and other services, you, the hirer, will be responsible whilst hiring this equipment, and ensure that all possible steps are taken to avoid injury or damage to it. The hirer must be aged 18 or over.

Please ensure all safety instructions and guides are followed.

- It is the responsibility of the hirer to take duty of care and supervise children when hiring equipment.
- It is the hirers responsibility to check there is enough room for the number of tipi's hired (please see our FAQs for measurements) When setting up if there isn't enough room, Tiny Tipi Co. will not refund the price of tipi's unable to fit.
- Any items that might tear or scag the equipment must be removed and any make up or face paint removed before entering the tipi.
- Shoes must not be worn inside the tipi's.
- No smoking or pets to be near the equipment.
- Keep all naked flames away from the equipment.
- No food, drinks, sweets or chewing gum are allowed in the tipis. Trays are provided to encourage eating and drinking outside of the tipis.
- No sharp instruments are allowed in or around the equipment.
- The tipis and equipment are for indoor use only.
- All equipment/products are not suitable for children under 5 years old unless you have had permission from The Tiny Tipi Co.
- All prices are subject to change, however prices quoted at the time of booking will always be honored.
- Equipment seen in photography may be subject to change but will always be swapped for the equivalent.
- All booking require a 20% deposit to secure the date. If an enquiry is made for the same date, the date will go to whichever party has paid the deposit first.

- All bookings require a security deposit. Any damages or stains to the equipment will result in your security deposit being nonrefundable and an invoice sent for any extra costs. The security deposit will be returned in full within 72hrs of collection and all goods checked.
- If your event is cancelled, we will offer an alternative date, if this is unsuitable we regret that the deposit is non-refundable. Please note cancellation 7 days or less before the booked date will result in 50% of the whole package being non refundable. If a further date is required the remaining 50% will go towards the payment for the new date.
- The Tiny Tipi Co. is not held responsible for any 3<sup>rd</sup> party costs or losses due to a cancellation of a party.
- Payment of the full package is due 7 days prior to your event date. If this is not received the date is no longer held.
- It is the hirer's responsibility to ensure all equipment is erected correctly and as per the instructions provided.
- The Tiny Tipi Co. Are not responsible for any accidents caused as a result of equipment not being erected correctly.
- The Tiny Tipi Co. are not responsible for any damage caused by the equipment to the hirer's household items when assembling the party.
- It is the hirer's responsibility to erect equipment so exits to the room are still accessible and free of trip hazards.
- It is the hirer's responsibility to only allow household members to view and use the equipment hired.
- It is the hirer's responsibility to package all equipment as it was found in the bags provided and leave on the doorstep at the time agreed by both parties.
- It is the hirer's responsibility to ensure all equipment is returned using the check list provided. Any missing items will be charged for out of the damage deposit, or invoiced for.
- Any equipment/props added to the set up and not provided by The Tiny Tipi Co. are the responsibility of the hirer and third party.
- It is both the hirer's and Tiny Tipi Co. responsibility to advise the other party if they are showing symptoms, come into contact with or are in the isolation period of Covid19.

- Both parties have the right to cancel at short notice if any members begin to show symptoms of Covid19. A full refund will be issued or party rescheduled.
- Force Majeure - The Company will not be liable for any: Act of God including but not limited to violent wind storm, fire, flood, rain storm or natural disaster; War, civil war, sabotage or act of terrorism; government sanction, global pandemic.
