BUYER AGREES:

- I agree to pay the fee of \$ _____ to help cover the seller's expenses of raising and caring for the kitten and is NON-REFUNDABLE.
- I agree and understand that all deposits are NON-REFUNDABLE unless the kitten becomes ill or passes away prior to transfer of ownership.
- I agree that the kitten mentioned above is being adopted by me. I agree that I will not sell, giveaway, or dispose of this kitten to any individual, establishment, or any other entity for any reason. If at a later date I am unable to keep this kitten, I agree to contact the seller to inform and give the option to repossess the kitten at no charge. If the buyer has a new home for the kitten, the seller has to approve of the new home, the new owners will have to sign and abide by this contract.
- I agree to take care of the kitten in a humane and responsible manner and to provide it with a clean adequate home, food, water and veterinary care.
- I agree that I am responsible for all vet bills once the kitten leaves the seller's home.
- I agree that neither party will make untruthful statements or discredit each-other online, or legal action will take place.
- I agree that the above kitten will be inspected by a licensed veterinarian within 72 hours of pick up. If the kitten is found to have a life-threatening condition, the seller must be informed on the same day as the diagnosis and a written statement from the veterinarian should be forwarded to the seller. A diagnosis of viral infections, coccidia, giardia, intestinal worms, fleas, mites, and other parasites are treatable, and not considered to be life-threatening. Failure to have the pet examined will void the seller's health guarantee.
- I agree if I purchased NO breeding rights I am required to spay/neuter my kitten within 6 months old.
- I agree if I purchased breeding rights I am required to breed to registered & health tested animals only.

SELLER AGREES:

- That the above kitten is up to date on all immunizations and dewormed according to age. This kitten is guaranteed to be in good health to the best of the seller's knowledge at the time of purchase.

By this contract, buyer attests to being at least 18 years of age and that this is a legal binding contract between the buyer and seller. The buyer certifies that all statements made on this agreement are true and correct. Buyer agrees that the seller has the right to confiscate the kitten in the event that any statements made by the buyer are found to be false. Buyer understands the above written contract and agrees to abide by all sections both typed and written. Both parties hereby agree to all the above agreements and terms. Any unremedied breaches within 5 calendar days of notification of said breach of this contract will result in buyer owing seller \$1000 per breach.
