If the pet is found to have a <u>life-threatening</u> condition, the seller must be informed on the same day as the diagnosis and a written statement from the veterinarian should be forwarded to the seller. A diagnosis of viral infections, coccidia, giardia, intestinal worms, fleas, mites, and other parasites are *treatable*, and not considered to be life-threatening. Failure to have the pet examined will void the sellers health guarantee.

• I agree if I purchased <u>NO breeding rights</u> I am required to <u>spay/neuter</u> my pet within 1 year.

• I agree if I purchased <u>breeding rights</u> I am required to breed to <u>registered & health tested</u> animals only.
