At PassedPics, we are committed to protecting your privacy. This Privacy Policy explains how we collect, use, and share your personal information when you visit our website www.passedpics.com, and use our storage services. Please read this policy carefully to understand our views and practices regarding your personal data.

1. Information We Collect

We may collect and process the following data about you:

a. Personal Information:

- **Account Information:** When you create an account, we may collect personal information such as your name, email address, and any other details you provide to set up your account.
- **Payment Information:** If you make a purchase or subscribe to our premium services, we may collect billing information, such as your credit card details (which are processed by a third-party payment processor).

b. Usage Information:

1. What are cookies?

2. How We Use Your Information

We use the collected information for the following purposes:

- **To Provide Our Services:** To create and maintain your account, provide storage, and manage your photos and files.
- **To Improve Our Services:** To analyze usage trends and improve the functionality, security, and user experience of the Site and Services.
- **To Communicate with You:** To send account-related notifications, updates, and promotional information (if you have opted in).
- **To Process Payments:** To process billing and payment transactions related to your use of our Services.
- **To Comply with Legal Obligations:** To comply with applicable laws, legal processes, and enforce our terms of service.

We do not knowingly collect or solicit personal information from anyone under 18. If we become aware that someone under 18 is attempting to redeem a Passed Key, the request will be denied. To ensure that all donees meet our age requirements, they must submit an age verification document during the redemption process.

8. International Transfers

If you are accessing our Services from outside the United States of America, please be aware that your personal information may be transferred to and stored in the United States of America or other jurisdictions where our servers and service providers are located. By using our Services, you consent to the transfer of your information to these locations.
