### ENTRY FEES:

(INCLUDING 25 CENT AKC RECORDING FEE)

\$10.00 FOR THE FIRST ENTRY OF EACH DOG, EXCEPT PUPPY CLASS WHICH IS \$7.00. EACH ADDITIONAL ENTRY OF THE SAME DOG IS \$7.00. WHEN A DOG IS ENTERED IN MORE THAN ONE CLASS, THE HIGHEST PRICED CLASS IS CONSIDERED THE FIRST ENTRY. ENTRY FEE WILL NOT BE REFUNDED IN THE EVENT THAT A DOG IS ABSENT, DISQUALIFIED, EXCUSED BY VETERINARIAN OR JUDGE OR BARRED FROM COMPETITION BY ACTION OF THE SHOW COMMITTEE. MAKE CHECKS PAYABLE TO THE LONE STAR SCHIPPERKE CLUB, INC.

"A RECORDING FEE OF 25¢ WILL BE REQUIRED FOR EACH DOG ENTERED AT ANY LICENSED OR MEMBER CLUB SHOW, OBEDIENCE TRIAL, OR TRACKING TEST.
