NOTICE TO EXHIBITORS

NOTICE

"Effective for all shows held on or after July 1, 1980, dogs which according to their owners' records have completed the requirements for a championship after the closing of entries for the show, but whose championships are unconfirmed, may be transferred from one of the regular classes to the Best of Breed or Variety Competition, provided this transfer is made by the Superintendent or Show Secretary prior to the start of the judging at the show".

"A Recording Fee of 25 cents will be required for each dog entered at any Licensed or Member Club show or Obedience Trial. This Recording Fee is to be collected by the show giving Club and paid to the American Kennel Club, if a dog is entered in more than one class in the show, the Recording Fee is to be collected on the first entry only. (American Kennel Club Rule, Chapter 15, Section 2)"

There will be no refund for duplicate entries.

Dogs need be present only for scheduled judging and will be released if not needed for further judging.

Dogs must be ready for judging. Neither the Club nor its Superintendents will be responsible or obligated to furnish any service for notifying exhibitors or their agents of Breed or Class Judging. Judges need not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the judging rings.

Space for unentered dogs will be provided at this show under the conditions specified in Chapter 15, Section 12 of AKC Rules Applying to Registration and Dog Shows.

Entry fee will not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge or barred from competition by action of the Show Committee.

No entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance. Entries will not be accepted without fees or signatures.

No entry fees will be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire, an Act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the Club or the Superintendent.

Changes, additions or corrections to entry forms must be received in writing or by telegram prior to close of entries. Those received by telephone are not acceptable.

The show giving Club, the Show Superintendent, their agents, employees, etc., assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property and further assumes no responsibility for injury to children.

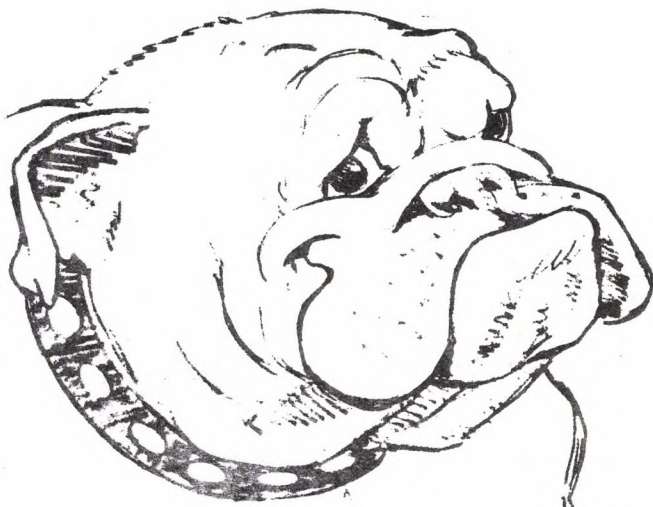
