DOG IS ENTERED IN MORE THAN ONE CLASS, THE HIGHEST PRICED
CLASS IS CONSIDERED THE FIRST ENTRY.

NOTICE TO EXHIBITORS

JUDGES ARE NOT REQUIRED TO WAIT FOR DOGS. THEY WILL ADHERE AS CLOSELY AS POSSIBLE TO THE JUDGING SCHEDULE. The owner or handler of each dog is solely responsible for having it ready at ringside when its breed is to be judged. The show-giving club and the Show Secretary have no obligation or responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

DOGS NOT REQUIRED for further judging will be excused.

ENTRY FEES shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of Show Committee. If, because of riots, civil disturbances or other acts beyond the control of the management it is impossible to open or to complete the show, no refund of entry fee will be made.

ALL DOGS PRESENT must be held on leash except when being judged, or in the exercising ring.

ENTRIES NOT ON OFFICIAL AKC ENTRY FORMS OR PHOTOCOPIES OF ENTRY FORMS without the Agreement and Rules on the reverse side of the Official AKC Entry Form are NOT ACCEPTABLE.

A RECORDING FEE of \$.50 will be required for each dog entered at any Licensed or Member Club show, Obedience Trial or Tracking Test. This Recording Fee is to be collected by the Show-giving Club and paid to the American Kennel Club. If a dog is entered in more than one class in the show the Recording Fee is to be collected on the first entry only. (American Kennel Club Rule, Chapter 15, Section 2).

RETURNED CHECKS do not constitute a valid entry fee. The Show Secretary will add a collection fee to the amount of each returned check. Subsequent returned checks from the same exhibitors may result in their being put on a CASH ONLY basis.

ERRORS ON ENTRY BLANKS. Owners are responsible for errors in making out entry forms, whoever may make such errors, and no entry fee will be refunded in the event of such errors or cancellation of entries after the published closing date.
