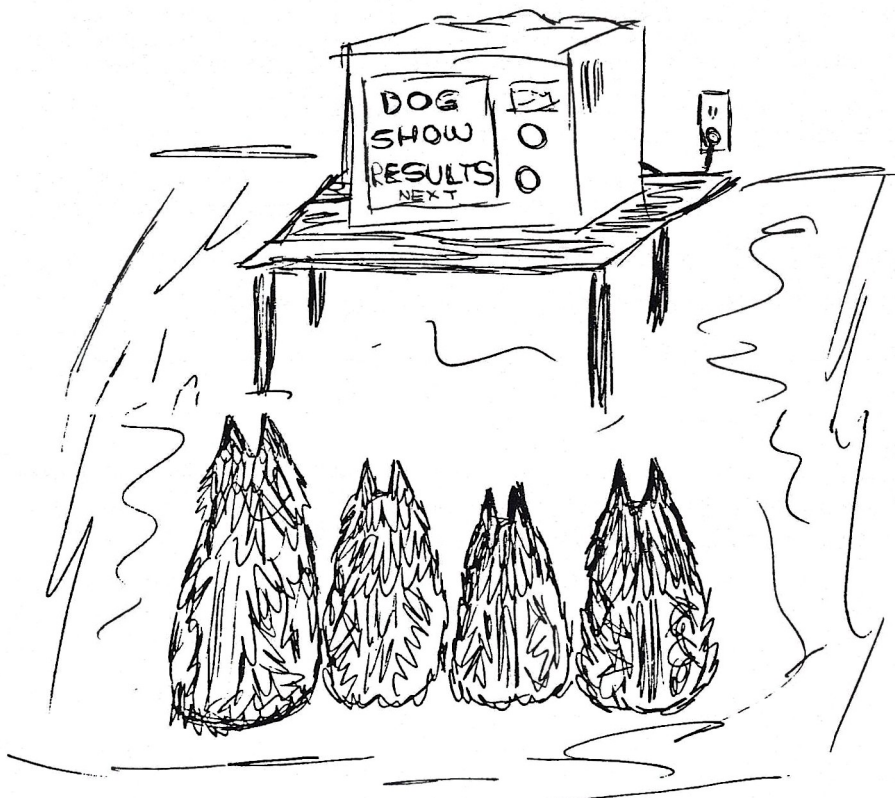

ATTENTION EXHIBITORS

"A recording fee of 50 cents will be required for each dog entered at any Licensed or Member Club show or Obedience Trial. This Recording Fee is to be collected by the show giving Club and paid to the American Kennel Club. If a dog is entered in more than one class in the show, the Recording Fee is to be collected on the first entry only. (American Kennel Club Rule, Chapter 15, Section 2)."

There will be no refund for duplicate entries.

Dogs need to be present only for scheduled judging. Dogs must be ready for judging. Neither the Club nor its Show Secretary will be responsible or obligated to furnish any service for notifying exhibitors or their agents of Breed or Class judging. Judges need not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the judging rings.

Returned checks do not constitute a valid entry fee. The Show Secretary will add a collection fee to the amount of each returned check.

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge or barred from competition by action of the Show Committee.

Entry fees will not be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of public enemy, strikes or any other cause beyond the control of the Club or Show Secretary.

The show giving Club, the Show Secretary, their agents, employees, etc., assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property and furthers assumes no responsibility for injury to children.

No entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance. Entries will not be accepted without fees or signatures.

Changes or additions or corrections to entry forms must be received in writing or by telegram prior to the close of entries. Those received by telephone are not acceptable.

EXHIBITORS NOTE: Please notify Show Secretary of any change of address.

All trophies must be claimed the day of the show. None will be mailed.

Our Annual Texas "Feed Bag" provided by the members of the Club will be in the Hospitality Room immediately after judging.

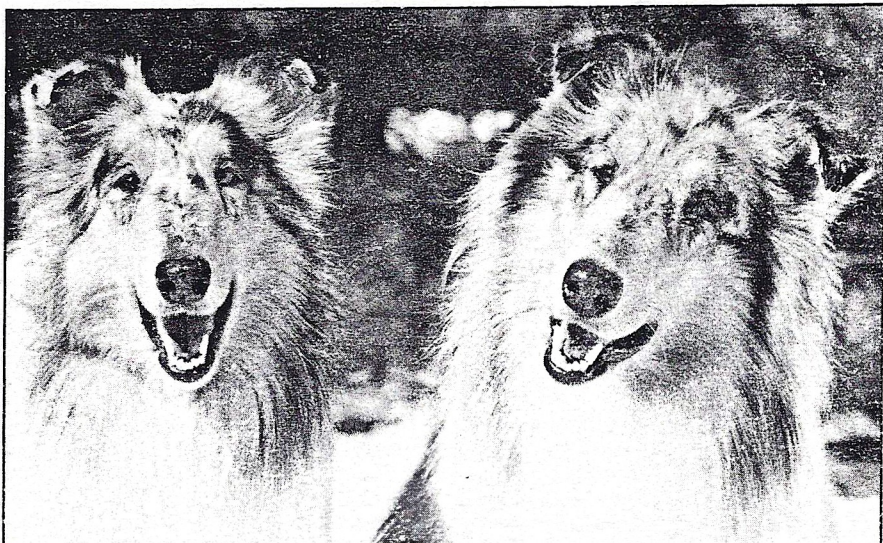
