Re: Peter J. Nygard Bahamian Court Matters

I am a practicing attorney-at-law having been duly called to the Bahamas Bar on the 26th September, 2003. I am extensively familiar with Peter John Nygard (Mr. Nygard), whom I represent, and all of his hereinafter mentioned court matters in the Bahamas which arose out of a property dispute with his immediate billionaire neighbour.

I have reviewed Mr. Nygard's 5th February, 2021 bail judgment of Justice Shawn Greenberg (Judge Greenberg) which makes reference to a Bahamas Court of Appeal decision dated 1st February, 2021 which states that Mr. Nygard did not attend court in the Bahamas on the 28th September, 2018. This statement is not correct. Mr. Nygard did attend court on the 28th September, 2018 as ordered and as evidenced in the attached transcript of the hearing on that date. The statement emanates from an affidavit of attorney Martin Lundy which erroneously misleads the court. Mr. Nygard's attorneys will clarify this matter with the Bahamian Court of Appeal and otherwise so as to vindicate Mr. Nygard of such misleading information presented to the court.

Mr. Nygard has always shown respect for the court and has attended except on occasions when he was medically unable and advised not to do so as a matter of life and death. Please see attached medical reports from Dr. Florence Comite and Dr. Douglas Schottenstein used before the Bahamian Supreme Court in relation to why he could not attend on the 21st January, 2019.

Also attached is an affidavit of Dr. Lynwood Brown which was used in the Supreme Court on the 28th January, 2019. Dr. Brown's affidavit exhibits the medical report of Dr. Harvey B. Lee who confirmed that Mr. Nygard was admitted to St. Boniface General Hospital and was under care of a team of experts including cardiologist Dr. Basem Elbarouni. Photos showing him admitted to St. Boniface Hospital with his wrist band and patient number are exhibited in the affidavit. Finally, Dr. Brown was asked to be tendered for examination but the court and counsel on the other side objected.

In spite of such overwhelming medical report evidence stated above and attached, the presiding Judge ordered Mr. Nygard to show cause while at the same time ordering the issuance of a bench warrant to arrest him. The Court of Appeal in the attached successful restoration of appeal judgment gave favour to Mr. Nygard in stating that his appeal has real prospect of success as follows:

"The Coalition also opposes the application for restoration on the ground that the appeal has no real prospect of success. Without deciding the merits of the appeal, I cannot accept that it is unarguable that the judge was wrong to require a party to appear to show cause why he should not be held in contempt and in the same order issue a bench warrant for at the same time order his arrest."

Mr. Nygard is awaiting hearing of the substantive appeal so as to have such Order quashed as appears to be the posture of the Court of Appeal in the above statement. It is clear that the Court of Appeal judgment referred to "one bench warrant" ordered at the above referenced hearing on the 28th January, 2019.

Finally, in the judgment of Judge Greenberg, she made her decision on two grounds, secondary and tertiary grounds, which she indicated in the last sentence of her judgment. Judge Greenberg did not order continued detention of Mr. Nygard on the primary ground (see paragraph 3 of the judgment which defines the primary ground).

The primary ground is whether the Canadian Attorney General on behalf of the United States can prove that it is necessary to continue detention of Mr. Nygard "to ensure his attendance in court." While Judge Greenberg did comment on his lack attendance in the Bahamas, this was not material to her decision due to her not basing such decision on the primary ground. In the circumstances, the said attendance concerns appear to become irrelevant on appeal.
