The hospital prices will be set by the package they buy from us. Each major surgery will be priced on its own and with a full package. Custom packages for hospitals will be available. This deal gives the hospital the rights to use the software for one year for all the procedures purchased. There will be a subscription fee for all the Vision Pro software. Doctors will still be able to use the software to detect cancer early and to practice the surgery procedures with the glasses until the FDA approval in the US. We will try to get a partnership with St Jude hospital for providing them the software for free to get more information on children's cancer to better update the software. The software will take 6 months to code so it will be ready for 2026 to sell. The sales person will do presales in 2025 to international hospitals in 2025. We have 5 companies that can help us get the Vision Pro approved by the FDA and we will work with Apple Computer Company to get this done. We will also work to get a discount on the Vision Pro glasses in a volume purchase information included with their contact information. The glasses will be getting a new computer chip this year.

We will setup pretrial FDA programs in 2026 in several hospitals to get a jump to getting to the final stage. AI Online Developer + will hire an FDA expert to manage all trials and to get us certified as soon as possible. Most of our business will be overseas so we will need to get the setup material and trainer available to the hospitals. The Vision Pro can also teach the doctors to go through the surgery on its own without a patient.
