

GOOSE LAKE ASSOCIATION CABANA RENTAL AGREEMENT

1. **Only one Host per Cabana.** That person is responsible for payment, clean-up and the behavior of their guests.
2. All parties are limited to 100 people or less. \$60.00 for B Cabana, \$50.00 for A Cabana, and \$30.00 for C Cabana, plus \$3.00 per guest over 10 years of age that exceed 50 people. A clean-up deposit of an additional \$100.00 is added to the rental cost. Rates include electric. .
3. A **DEPOSIT** of \$30.00 to hold a Cabana and a **SIGNED** Agreement at time of Cabana Rental is necessary to secure your rental. **NO RESERVATIONS BY PHONE.**
4. A **CLEAN-UP DEPOSIT/SECURITY** (\$100.00) must be tendered on day of Cabana usage. Clean-up deposit should be in the form of a **check**, which will be returned to the Host with in 2 business days provided Cabana and surrounding areas (playground and volleyball court) is left broom-clean, tables wiped and all debris bagged and placed in dumpster. Bags, broom and dust pan are available at Caretaker's house.
5. Cancellations must be requested **in writing** and postmarked no later than 15 days prior reserved date in order to receive a refund. **EXCEPTIONS BY BOARD APPROVAL ONLY.**
6. All **FIRES** are to be extinguished before leaving, charcoal is to be carried to containers provided, and **NO NEW FIREHOLES** are to be created.
7. The **CARETAKER** is in charge of the Beach and Campground, employed to promote safety and to enforce Club Rules.
8. Gates are opened at 7:00am on week-ends and closed at 10:00pm. All activities shall stop by 10:00pm. Failure to comply will forfeit your deposit. Parties may begin their set up the night before or the morning of the event starting at 7:00am. Depending on availability.
9. Lifeguards are on duty Memorial Day thru Labor Day, 6 days a week closed on Tuesday, **WEATHER PERMITTING!!!**
Swimming is permitted at Beach only and when lifeguards are present.
10. There are forms available at the Caretaker's house for suggestions and/or comments. **PLEASE LET US HEAR FROM YOU.**
