## ENTITLES MEMBERS TO THE FOLLOWING BENEFITS:

- ❖ FISHING BOAT (10hp OR LESS) PRIVILEGES ON GOOSE, BEAVER, HALF MOON AND LINCOLN LAKES.
- ❖ BOAT AND SHORE FISHING PRIVILEGES (EXCEPT FROM PRIVATE PROPERTY AREAS) ARE AVAILABLE.
- ❖ USE OF MARINAS FOR LAUNCHING YOUR BOAT.
- ❖ USE OF STORAGE AREA FOR BOATS ON TRAILERS AND CAMPING VEHICLES AT A COST OF \$170.00 PER UNIT, PER SEASON. SMALL BOAT STORAGE IS ALSO AVAILABLE AT \$60.00 PER SEASON.
- ❖ SWIMMING AT THE BEACH WHEN LIFEGUARDS ARE ON DUTY.
- ❖ AREAS ON THE CLUB GROUNDS ARE SET ASIDE EXCLUSIVELY FOR CAMPING AND PICNICS.
- ❖ PAVILION RENTAL AVAILABLE FOR PARTIES LIMITED TO 60 (SIXTY) GUESTS OR LESS.
- ❖ HALL RENTAL AVAILABLE.
