Listed below are the voting results for the proposed By-Law changes. As stated in the current GLA By-Laws dated 9/15/12, “no amendments or changes to these bylaws will become effective without the affirmative vote of two-thirds of those members voting in person or by mail”. As a result, with a total of 261 members voting, the proposed By-Law changes were approved with more than the required 174 voting in favor of the proposed changes.
