Goose Lake Association Rules

REVISED July 31, 2023



GENERAL RULES:

- 1. **OPEN MEMBERS** These are classified as "A" and "B" Memberships. Membership for Open Members is a "Family Membership" and includes husband, wife and unmarried children under 21 years old living with member at address on file with GLA.
 - "A" Membership has boat (10 HP or less) or 2 single person kayak privileges on Goose, Beaver, Half Moon and Lincoln Lakes. Boats may be stored only at the Goose Lake Association designated storage area. The use of pontoon boats, speedboats, or personal watercraft (jet skis, etc.) is not permitted on any lake.
 - "B" Membership has shoreline bank fishing privileges on Goose Lake within the boundaries of the campground. There are **no ice fishing** privileges for "B" membership.

Point of entry to the beach and campground for Open Members is at the Main Gate on Goose Lake Road.

- **2. PROPERTY OWNER MEMBERS** These are the property owners who have access to Goose Lake Association Property and Lakes. Membership is a "Family Membership" and includes husband, wife, and children.
- **3. GENERAL POLICY -** The Goose Lake Association does not sanction scuba diving, snowmobiling, or swimming in/on lake waters. The Goose Lake Association has jurisdiction over its members' permitted uses of the lake waters.
- **4. CURFEW** Anyone under 18 years of age not under the direct supervision of an ADULT MEMBER must leave the Association grounds by 10:00 p.m.
- **5. PERMISSIVE USE** The Goose Lake Association does not assume liability for accidents to persons using its recreational facilities (includes beach, campground, marinas, parks, lakes, and other Goose Lake Association property).
 - (a) Property owners shall not allow the use of their watercraft on Association Lake waters or vehicles on Association property by non-members unless they accompany them or are present on their property on such occasions. Property owners must accompany guests when using the beach, picnic or campground areas.

- (b) Property owners shall not allow any non-members access to GLA lake waters (frozen of not) or GLA property with any watercraft or motorized vehicle that does not have a current GLA decal.
- (c) Open members shall not allow the use of their boats on association lake waters or vehicle on Association property by non-members, and must accompany guests when using the beach, picnic or campground areas.
- **6. FINES** All fines are to be paid within forty-five (45) days of issuing date of ticket. A \$10.00 penalty per month will be assessed until the fine is paid.
- 7. GRANDFATHER CLAUSE A Grandfather Clause is an exception that allows an old rule to continue to apply to some existing situations, when a new rule will apply to all future situations. As a result, any watercraft that does not meet the requirements of Sections 6.1, 6.2, or 6.6, and are decaled as of November 26, 2007, are "grandfathered in." "Grandfathered in" watercraft will not be issued 2008 or later decals if transferred, gifted, dropped from decaled status and/or sold with the property or to another Goose Lake Association member.
- **8. VISITORS ON GLA PROPERTY** Members may purchase vehicle pass from the GLA office annually for the cost of \$50.00

This pass must be displayed on your guest's windshield and you must accompany your guests at all times on GLA property.

If a member has 10 or more guests, they must obtain and complete a pavilion rental form in order to use the facilities. To obtain a rental form you must go to the GLA office during office hours. In off hours you must obtain a form from a life guard on duty. Failure to comply with these rules can result in a forfeiture of your usage of all GLA gates properties.

TO PROMOTE SAFETY, THE FOLLOWING RULES SHALL APPLY:

SECTION 1.0: SPECIFIC RULES:

SECTION 1.1: MAIN GATE

Entrance to the Main Gate (MG) is only permitted from Goose Lake Road. The MG gate is activated by the keycard credential reader. To activate the main gate, present the GLA approved key card credential to the reader. A short beep is emitted, indicating that the credential is read properly then the gate should open, once the gate is fully open proceed slowly through the MG entrance. For those who walk or bicycle to the MG entrance you will be required to use the small personnel gate to the south of the MG. The personnel gate will be unlocked during normal beach hours but locked once the beach is closed. When leaving, the MG will automatically sense your vehicle (this includes motorcycles, golf carts, UTVs) and open, once the gate is fully open proceed slowly through the MG exit. All members are responsible for assuring the MG closes behind them when entering or leaving the GLA club. Any member allowing unauthorized visitors or vehicles through the main gate will be subject to fines.

Two gate key cards per member may be obtained from the GLA office for \$10.00 fee per key card. Keys will be individually numbered and registered in the name of the member.

SECTION 1.2: VEHICLE DECALS

A copy of the member's current vehicle registration must be provided to receive a GLA decal. A current decal shall be permanently affixed on the right side, lower half of your windshield decal when on Goose Lake Association property. There is a limit of four vehicle decals per property owner and "A" and "B" Open Members at a cost of \$18.00 per decal.

A member may request a variance to obtain a decal for a non-owned vehicle (rental or leased may qualify). A written letter stating the reason for the request along with appropriate vehicle documentation and insurance coverage must be submitted for approval prior to a decal being issued.

Violation of this regulation shall result in a fine of \$50.00 for the first violation and \$100.00 for a second, and all subsequent violations, which are attributed to the owner of the vehicle involved in the violation. Such fine shall become an automatic lien on the real property of the vehicle owner or revocation of membership privileges if an Open Member. In addition to a fine, vehicles in violation of this regulation are subject to being towed at owner's expense.

SECTION 1.3: MOTORCYCLES

Motorcycles will be permitted on the Association Grounds only if they have a valid state license plate and a current vehicle decal permanently affixed. No guests' motorcycles are allowed on the Beach or in the Campground Area. Guests on motorcycles are to park in Main Parking Lot.

SECTION 1.4 A: GOLF CARTS AND UTV'S

Golf carts/UTV'S will be permitted on the Association Grounds only if they have a current decal permanently affixed. No guests' golf cart/UTV's are allowed and member golf carts/UTV's shall stay on designated campground roadways. Operator of golf cart/UTV must be 16 years of age of older with a valid driver's license. Certificate of liability insurance shall be required before golf cart/UTV decals will be issued. All golf carts/UTV must carry a minimum of \$200,000.00 insurance liability for personal injury and property damage.

SECTION 1.4 B: UTV'S

All UTV's decibels will be measured prior to the purchase of a decal. UTV's are to be measured by the Goose Lake Association and are limited to 96 decibels. The UTV's decibels can be re-measured at any time of the request of a board member or upon any noise complaint.

SECTION 1.5: ASSOCIATION PROPERTY USE

- (a) Association Property shall not be used for pleasure use of sport vehicles of any kind including, but not limited to snowmobiles, dirt bikes, go-carts, dune buggies, ATVs, etc.
- (b) The term "Association Property" shall in this context be deemed to <u>include</u> the waterways, whether frozen or not, which may be used in accordance with applicable State Law. This provision does not mean that the Association in any way sanctions the use of any sport or recreational vehicle.
- (c) Recreational or sport vehicles used for transportation purposes shall be allowed into the parking area of the Main Building, and then for parking purposes only.
- (d) All recreational or sport vehicles are subject to all applicable State and Municipal Laws and Ordinances.

- (e) Littering on any Goose Lake Association Property by residents, open members, or hosts of any littering guests, shall be punishable by an automatic fine of Fifty Dollars (\$50.00).
- (f) Per Animal Control guidelines, pets shall be leashed on all association grounds with an <u>8-foot</u> maximum leash allowance. Pets must be prevented from disturbing campers and picnickers. Pet owners are responsible for cleaning up pet excrement. Pets are not allowed in the beach area. No guest pets are allowed. Owners of unleashed pet(s) are subject to a \$50.00 fine.

SECTION 2.0: BEACH

SECTION 2.1: BEACH AREA

The beach is under the supervision of the Beach Chairperson. The lifeguards are there for your safety, please cooperate with them, and the following rules:

- (a) Pets, alcohol, glass and fires are not allowed on the beach area.
- (b) There is absolutely NO EATING OR SMOKING allowed on the sandy portion of the beach.
- (c) Eating, and smoking are only PERMITTED is designated areas or while in the beach cabana areas.
- (d) All children who are not toilet-trained shall wear diapers that are designed for use while swimming or bathing.

SECTION 2.2: SWIMMING

- (a) Swimming will be allowed at the beach only when lifeguards are on duty.
- (b) There will be a 10-minute safety break every hour. All swimmers **MUST** be out of the water, off the rafts, and off any diving equipment during the 10-minute safety break.
- (c) Any child, 13 years of age or older passing the GLA Swim Test (see 1 below), can swim at the beach unaccompanied by an adult. Any child, under 13 years of age who hasn't passed the GLA Swim Test as identified below, must be accompanied by a parent or supervised by someone 16 years of age or older.
 - 1. A swimmer is defined as a person able to swim the length by the lifeguard on duty.
- (d) Non swimmers are prohibited from going beyond the North/South rope.
- (e) Appropriate swimwear is required. No underwear, thong bathing suits, or suits that are deemed too revealing by the lifeguard for a family environment because of transparency, cut, or tightness of fit.
- (f) No swimming at the marinas or in the campground area.

SECTION 3.0: FISHING

SECTION 3.1: FISHING AREA

Boat and shore fishing privileges (except from private property areas) are available to Property Owners and "A" Open Members only in the various Association areas. "B" Open Members are allowed shore fishing only on Goose Lake within the boundaries of the campground.

(a) "A" Open Members are allowed ice fishing privileges, and are allowed one guest while ice fishing. A per member combined bag limit applies for the guest, and they must follow all GLA rules.

SECTION 3.2: LIMIT

A DAILY FAMILY LIMIT OF 6 GAME FISH (black bass, walleye, catfish and northern) has been set. For example, a property owner or family members with two (2) guests are permitted to catch only 6 game fish BETWEEN them.

PLEASE NOTE THAT THIS IS NOT AN INDIVIDUAL LIMIT. Please take and destroy all carp. A (25) combined bag limit of sunfish with a (10) crappie maximum included in the combined sunfish limit has also been set.

To assure these limits are followed and ensure better fishing for everyone, stringer or live-well checks may be requested by the GLA officers, Board Member, DNR, Safety Patrol or any property owner. All fishermen and guests are required to cooperate.

(a) A general guideline for fish size limits can be found on the GLA website, you may also obtain a copy at the GLA office. Signs will be posted at each marina and other various areas.

SECTION 3.3: LIVE BAIT

No live baits (minnows, worms, crayfish, etc.) are to be dumped or released into the waters, except by the GLA Fish Committee.

SECTION 3.4: METHODS

No night lines, trout lines, or jug fishing will be allowed. These lakes are for sport fishing only.

SECTION 3.5: FISHING REGULATIONS

Although this is a property owners' Association, all members are required to have a valid State of Illinois fishing license and to abide by the Illinois Department of Conservation fishing laws.

SECTION 4.0: PICNICS

SECTION 4.1: PICNIC AREA

All picnics on Association property will be held in the picnic area only. Any member with twenty or more people for a rental must request a permit in advance from the GLA office.

A Picnic Pavilion may be reserved by contacting the GLA office. TO USE A PAVILION, A RENTAL FEE AND A SIGNED PAVILION RENTAL AGREEMENT ARE REQUIRED. The total cost of a Pavilion rental is based on which Pavilion is rented along with a clean-up deposit. Rental rates are included in the Goose Lake Association Pavilion Rental Agreement for. The clean-up deposit will be returned if Pavilion is left broom clean, tables wiped, and all debris bagged and placed in dumpster. All parties are limited to 100 people or less and all people attending must sign in at the main gate when arriving.

The personnel gate as well as the main gate will be manned from one (1) hour prior to each Pavilion rental. All guests must obtain a guest pass for pavilion rentals from the gate attendant to be displayed in the window of their vehicle while on association property.

CANCELLATIONS MUST BE REQUESTED IN WRITING, POSTMARKED NO LATER THAN 15 DAYS PRIOR TO RESERVED DATE IN ORDER TO RECEIVE A REFUND.

SECTION 4.2: PICNIC RULES

All picnickers will keep the picnic area clean and be sure the area is clean before they leave. All campfires must be extinguished. HOT COALS AND CHARCOAL MUST BE PLACED IN PROVIDED CONTAINERS. Members will be responsible for their guests while on grounds. Beach cabanas cannot be reserved.

SECTION 5.0: CAMPING

SECTION 5.1: CAMPING AREA

A defined area on the club grounds has been set aside exclusively for campers. All tents, camping trailers, motor homes and/or other vehicles used for camping on GLA property must display a current Goose Lake Camping Decal on the right front side of vehicle or front of tent. A copy of the member's current camping unite (excluding tents) registration or proof of ownership must be provided to obtain a GLA decal.

CAMPING IS NOT ALLOWED WITHIN 50 FEET OF THE CAMPGROUND PAVILIONS. CAMPERS OR CAMP TRAILERS ARE NOT ALLOWED TO PLUG INTO THE CAMPGROUND ELECTRIC. For Camper/tent decals pricing see "GLA General Fees". Seasonal camping will be between April 1st thru November 15th, weather permitting.

SECTION 5.2: GUEST CAMPER USE

No guest trailers, vans, tents or campers will be allowed. Guest may stay in the property owner's/open member's single unit facility only, and must be accompanied by the property owner/open member. Property Owner/Open Members cannot provide extra facilities for guest camping such as vans, tents, or campers.

SECTION 5.3: REGISTRATION

Campers will obtain their registration form from the phone box on the south side of the caretaker house. Using black pen, legibly complete the registration form. The bottom hard copy goes in the front window closest to the camper's entrance, (in front of the screen) to be seen by the Campground Director. The top paper copy is returned to the phone box. Be sure the ENTIRE registration form is completed.

SECTION 5.4: SITE MAINTENANCE

All campers, tents and equipment will be removed from the campground at the end of stay, and the campsite, including fire pit, shall be cleaned up of all litter and debris. **CAMPERS ARE TO BE MOVED TO A DIFFERENT SITE EVERY 2 WEEKS AND TENTS ARE TO BE MOVED TO A DIFFERENT SITE EVERY WEEK.** Campers not moved after a two week stay and tents after a one week stay, will be assessed a fee of \$5.00 per day for each day in excess of two weeks or tents after seven days until the unit is moved. Any camper exceeding the two week or seven day stay requirement may have their camping privileges revoked. The Campground is to be used for camping and not as a storage area for campers. Paid storage is available to park your camper while it is not being used for camping from **April 1**st **to March 31**st. Camping units, which are only used periodically, will be required to be removed from the campground. Campers are to notify the Campground Director if their camping unit will be unoccupied, the reason why, and for what length of time.

SECTION 5.5: RESTRICTIONS

No house trailers will be allowed.

SECTION 5.6: CAMP SITES

All campers will keep their campsites clean and neat while they are camping and be sure the site is clean when they leave.

SECTION 5.7: SUPERVISION

No unsupervised camping by minors under age 18. Family memberships do not permit children to camp overnight without supervision by an adult family member.

SECTION 5.8: REFUSE

All campers shall use plastic garbage bags when camping and deposit them in dumpster before leaving. Any coals must be completely extinguished and placed in the provided containers next to the dumpster. Coals should not be placed in a plastic bag. Anyone caught littering Goose Lake Association property or waters may be subject to a \$50.00 fine and/or permanent expulsion from all Association privileges or other appropriate penalties.

SECTION 5.9: NOISE

QUIET SHALL BE MAINTAINED BETWEEN 10:00 P.M. AND 7:00 A.M. IN THE CAMPGROUND.

SECTION 6.0: BOATING & WATERCRAFT

SECTION 6.1: BOAT SIZE/WATERCRAFT SIZE REGULATIONS

Pontoon Boats are limited to an overall length that does not exceed 24 feet 6 inches with not more than two pontoons (tubes). All other watercrafts are limited to an overall length that does not exceed 20 feet as per original boat manufacturer specification and must measure 20 feet or less as measured by the Goose Lake Association. Measurement shall include molded platforms; excludes bolt-on platforms. The maximum overall width of any boat is to be no wider than 9 feet. The following watercrafts are prohibited:

- (a) Watercraft equipped with inboard rear engines including, but are not limited to, V-drive boats, inboard/outboard boats, and jet boats or any boats/watercraft that are equipped with any wake or wake enhancing devices such as, but not limited to, ballast tanks, hydro gates, etc.
- (b) Cabin cruisers or other boats with enclosed living quarters
- (c) Deck Boats
- (d) Tritoon Pontoon Boats [having three or more pontoons (tubes)]
- (g) Any boat/watercraft or water device is subject to evaluation by the GLA Board of Directors.

SECTION 6.2: BOATING AND USAGE

(a) The marinas have been constructed for the launching of properly registered watercraft. All unattended watercraft must be taken out of the water and kept in the designated Goose Lake Association storage areas (or at owner's property). A key to the Marinas may be issued to

property owners and "A" members at a cost of \$10.00 only if a boat or other properly registered watercraft decal is purchased.

- (b) Any watercraft found to be creating excessive waves will be subject to the fines and penalties as stated in Section 6.8: Boat Fines, Penalties, and Violations; Which included but not limited to:
 - 1. Surfing
 - 2. Overloading or operating a vessel that has been loaded beyond the recommended carrying capacity beyond the limits shown on the capacity tag plate installed by the manufacturer, which includes the person or persons in tow.
 - 3. Overloading or operating a vessel with excessive people/weight in the rear of the boat.
- (c) All Watercraft shall be equipped and maintained with an effective below waterline exhaust system.
- (d) Boats used on Goose, Beaver Lake, and Half Moon Lakes shall not be equipped with more than a 10 HP motor. Boats on these lakes are limited to **NO WAKE** speeds. Pontoon boats are limited to no more than 100 HP on Lincoln Lake.
- (e) Jet Skis are limited to no more than 130 HP. Operators and owners of jet skis and other like personal water craft shall obey all rules concerning "flow" of watercraft direction and shall not operate in such fashion as to endanger themselves, passengers, or other users of the lake. PULLING OR TOWING OF WATER SKIERS OR PULL CRAFT WITH JET SKIS IS NOT PERMITTED.
- (f) Pontoon Boats are not allowed to pull anything or anyone on Lincoln Lake. All other lakes are limited to pull a single tube in a straight-line fashion.

SECTION 6.3: WATERCRAFT DECALS

Watercraft's must display all current year decals whenever on the water or docks on GLA waterways. Failure to display a current year decal will be subject to incur a fine.

A copy of the member's current boat registration must be provided to receive GLA watercraft decals. All watercraft must have the proper Goose Lake Association identification (lake/lot) numbers and current year decals affixed to both the port (left side of watercraft) and starboard side (right side of watercraft) nearest to the rear. GLA decals and lot numbers should not be placed any farther forward than mid-point of the watercraft and well above the waterline so that they are in plain view. Watercraft having side facing windshields on both (port & starboard) sides of the watercraft can display current GLA decal and lot number on side windshields only if this can be done without obstructing the driver's vision.

In addition, the Illinois state registration numbers and current year decals are required on both the port and starboard sides on the front of the watercraft. Goose Lake Association identification numbers and Illinois State registration numbers should be of block characters at least 3 inches in height and in contrasting color to their background. Failure to display two (2) identically numbered decals and proper lot numbers on each and all watercraft will result in a fine as stated in Section 6.8: Boat Fines, Penalties, and Violations. Expired Goose Lake Association and Illinois State decals should be removed.

(a) New boats/watercraft procedure to include lot numbers being installed in the proper location on the boat/watercraft before the boat/watercraft is measured.

SECTION 6.4: INSURANCE

Certificate of liability insurance with current effective dates shall be required before boat/watercraft decals will be issued. All boats must carry a minimum of \$500,000.00 insurance liability for personal injury and property damage. Effective 2023.

SECTION 6.5: WATERCRAFT OPERATION RULES

- (a) All Coast Guard and Department of Conservation rules are hereby adopted and to be obeyed.
- (b) No water skiing shall be permitted from the period of 1/2 hour after sunset to 1/2 hour before sunrise, or as stated in Department of Conservation Rules and Regulations (625 ILCS 45/5-14 Boat Registration & Safety Act).
- (c) No boat shall pull more than two (2) skiers or tubes at one time except for pontoons, see Section 6.2(f). No boat shall pull anyone with a shorter tow rope than 25' from the rear of the boat. The operator of any watercraft that is towing a person or persons shall display on the watercraft a bright or brilliant orange flag measuring not less than 12 inches per side. The flag shall be displayed at the highest point of the area surrounding the boat's helm as to be visible from all directions, continuously while the person or persons being towed depart the boat in preparation for towing and until reentry into the boat when the activity has ceased. Display of the flag for purposes other than the activity described in this Section is prohibited.
- (d) No boat or watercraft shall be operated on any lake after dark except with proper lighting and at a slow speed.

SECTION 6.6: NUMBER OF ALLOWED WATERCRAFT

- (a) No more than seven (7) watercraft units are allowed per property, of which no more than a total of four (4) watercraft units can be motorized (motorized includes both electric and gas).
- (b) The max number of decals for Personal Watercraft that will be issued by the GLA in a given year will be 120 under the following guidelines:
 - 1. Jet Skis No more than 100 PWC decals will be active at any given time during each year for Jet Ski use. GLA will reserve decals for renewal from the previous year until April 1st of the current year. If the decals are not renewed by April 1st, the decals will be issued to property owners from the waiting list on a first come first served basis.
 - 2. eFoils Maximum limit of 8276 watts (10 hp). No more than 20 PWC decals will be active at any given time during each year for eFoil use. GLA will reserve decals for renewal from the previous year until April 1st of the current year. If the decals are not renewed by April 1st, the decals will be issued to property owners from the waiting list on a first-come first-served basis.

SECTION 6.7: SAFETY PATROL

- (a) No person shall resist, obstruct or otherwise interfere with the actions of any member of the Goose Lake Association Safety Patrol while said individual is involved in the performance of their duties.
- (b) The operator of any watercraft on or adjacent to Goose Lake Association, upon being signaled to do so by a member of the Goose Lake Safety Patrol, an officer of the Department of Conservation, an officer of the Sheriff's Department or property owner, shall immediately bring their watercraft to a stop. Failure to do so shall result in the assessment of a fine or such other sanction as deemed appropriate by the Board of Directors.
- (c) A signal to stop a watercraft shall be deemed appropriate if it involves a horn, voice, siren, flashing lights, or such other signal sufficient to put a reasonable person on notice that a stop of the watercraft was requested.

SECTION 6.8: BOAT FINES, PENALTIES, AND VIOLATIONS

It shall be illegal and unlawful for anyone to operate a boat on any lake within the jurisdiction of Goose Lake Association without having first complied with current By-Laws and Rules. Said Decal shall be affixed as required before boat usage. It shall further be a violation to operate any boat in violation of any of the following boating safety regulations:

Inadequate personal flotation devices; careless and dangerous operation of watercraft; any other violation of State boating laws; littering into the lakes; excessive speed in "no wake" areas; water skiing or tubing within 1/2 hour after sunset to 1/2 hour before sunrise*; failure to have observer while skiing or tubing; failure to use running lights on watercraft.

The Skier-Towing Flag *(625 ILCS, 45/5-14 Boat Registration & Safety Act)

Vessels towing persons on water skies or other devices must display a skier-towing flag from the highest point around the vessel's helm so that it is visible from all directions at all times while a person is in the water preparing to be towed, while the person is being towed, and until the person has re-entered the vessel. The flag may not be used for any other purpose. The flag must be bright orange and at least 12" X 12" in size.

Violation of the above regulations shall result in a fine of \$50.00 for the first violation and \$100.00 for a second violation and all subsequent violations, which are attributable to the owner of the boat involved in the violation. Such fine shall become an automatic lien on the real property of the boat owner.

ILLINOIS BOATING LAWS MUST BE OBEYED BY ALL MEMBERS AND THEIR GUESTS!

SECTION 7.0: BOAT & CAMPING STORAGE FACILITIES

SECTION 7.1: STORAGE AREA

The storage area at the southeast portion of Goose Lake property south of Main Building is set up to be used

by members for storing boats on trailers or camping vehicles during the period from April 1st to March 31st. Storage facilities are provided for rent as a convenience to members. Goose Lake Association assumes no liability or responsibility for the loss or damage of any property when using the storage area.

SECTION 7.2: STORAGE FEES

Large and Small Boat Storage Area - Fees ARE LISTED IN THE GLA OFFICE AND ON THE GLA WEBSITE. Fees paid after April 1st shall bear a monthly late charge (See fines and fee list.) A car decal must be purchased before a key can be purchased. A charge of will be levied for any lost keys.

SECTION 7.3: PENALTY

In the event that the required fee is not paid for any boat or camping vehicle by April 1st, such unit shall be subject to be towed at owner's expense and disposed of according to State Law. On or after April 10th of each year, boats left in the Small Boat Storage Area will have locks removed and boats will be disposed of without further notice to owners. Locks for boats are to be provided by owners.

SECTION 8.0: DECALS AND KEYS

SECTION 8.1: DECALS & FEES

Decals shall be required for the following units in the number designated in Section 6.6 which states that no more than **seven** (7) watercraft units are allowed per member of which no more than a total of four (4) watercraft units can be motorized. The watercraft decal fees are in effect as of January 1st of each year.

SECTION 8.2: KEYS & FEES

Two Campground keys shall be issued per property owner or open member. COST OF REPLACEMENT KEYS. **One** (1) Marina Key may be issued to property owners and "A" open members if a boat or watercraft decal is purchased. The cost of keys and the replacement fees will be listed on the FINES AND FEES LIST LOCATED AT THE GLA OFFICE OR GLA WEBSITE.

SECTION 9.0: LAKE WATER USE

The Goose Lake Association pursuant to its By-Laws hereby exercises authority over its members' use of the lake waters of Goose, Beaver, Half-Moon, and Lincoln Lakes. The Association's members will abide by its assertion of authority and rule making, as set forth below:

(a) Members, property owners, or guests shall not fill the lake with soil or other materials including but not limited to rip-rap, sea walls, boat docks, etc. or alter the shoreline in any way unless a permit with written approval is acquired from the Goose Lake Association Board of Directors or designated committee. All members will follow the Shoreline process and guidelines as are in effect at the time of permit approval. Each individual project will require that a Goose Lake Association permit process be followed by the property owner prior to the start of any shoreline modification or work.

A permit and fee will be required for the following shoreline modification or work:

- i. replacement of existing,
- ii. minor/small projects,
- iii. major projects
- (b) Fees are determined by the GLA Shoreline committee, all fees are listed in the GLA office and the GLA website. All charges will be paid by the property owner PRIOR to the start of any project. Upon project approval, permits will be posted at the affected lakefront property in plain view prior to the start of any construction and will remain posted until construction is completed.
- (c) The violation of these rules or current guidelines by an Association member, open member, or guest will result in the Association's assessing a sanction or punishment against that violator. The Board may choose at its discretion, to levy a fine of not less than One Hundred Dollars (\$100.00) and a maximum of Five Thousand Dollars (\$5,000.00) per each violation against the member. The Association may also elect to file suit for Injunctive Relief to prohibit such use and to require that the property or lake be returned to its original condition prior to the violation occurring. In such an injunctive suit, the Association pursuant to these rules and By-Laws shall be entitled to recover from the violator the Association's costs and attorney's fees.
- (d) No fishing structures or any other materials, manmade or natural, are to be placed into any of the lakes without prior approval of the Goose Lake Association Board of Directors. The proposed design and materials for such structures must be environmentally safe for the lake.
- (e) All construction practices and locations shall comply with all state, county or municipal building codes.
- (f) Discharging, blowing / throwing leaves, grass or yard waste into the lake is considered littering and is prohibited.

(g) Future Construction will not be allowed to dispose of Water Softener and Water Treatment System or backflush contents into our Lakes or Ditches.

SECTION 10.0: SPECIAL

THERE SHALL BE NO DEVIATION OR VARIANCE FROM THE ASSOCIATION RULES UNLESS APPROVED BY THE GOOSE LAKE ASSOCIATION BOARD OF DIRECTORS.

VIOLATIONS OF GOOSE LAKE ASSOCIATION RULES WILL RESULT IN FINES, SUSPENSION, OR PERMANENT EXPULSION FROM ALL ASSOCIATION PRIVILEGES. FINES WILL AMOUNT TO NOT LESS THAN ONE HUNDRED FIFTY DOLLARS (\$150.00) PER EACH VIOLATION ULESS NOTED OTHERWISE. ALL MEMBERS ARE RESPONSIBLE FOR THEIR GUESTS' ACTIONS.

Any member who has been issued a violation shall have the right to a "due process" hearing at the next monthly meeting of the Board of Directors of the Goose Lake Association. They shall be entitled to present evidence and make a statement. The decision of the Board of Directors by a majority vote shall be final.
