Vote unanimous, motion carried. Office desktop is in need of replacement. Eric Pershey made a motion seconded by Mike Poeschel to replace with a new desk top not to exceed the cost of 1500.00. Vote unanimous, motion carried.

5 applications came in for part time seasonal office help.

Audit for first quarter was done Joe Turk read the audit results. Discussion of past uncashed payroll checks was addressed.

Tom Morris asked to be removed from all association bank accounts.

Bar-Gina (bar manager) gave her monthly report. Talked of promotional item given away and future entertainment. Copy right policies were discussed with BMI fees regarding infringement rights. Spoke about files on banned patrons. Barb Peters asked about two separate incidences at the bar involving board members and was told it was a closed session matter.

Tom Mosey brought in quotes for bar and kitchen floor repair after much deliberation was asked to bring back a quote for full replacement vs. repair.

Campground-Cleaning and clearing brush is being continued. Mike Poeschel spoke of the amount of geese present and would like to move forward with removing by legal means.

Beach-Floor area is complete, quote for partitions was presented Kyle Oaks made a motion seconded by Jim Grady for Vanity sinks and partitions not to exceed 4500 dollars. Vote unanimous, motion carried.

Fish- Phil Sheedy got a quote for a work barge to carry structure out to the lakes from McCoy marine. Money was already approved. Phil Sheedy made a motion seconded by Jim Grady to move forward with a fish survey in late April or early May at the cost of 3500.00 Vote unanimous motion carried.

Maintenance- Plate still in dam.

Safety-nothing to report.

Social- Easter egg hunt is April 20th at 1:00 pm can always use volunteers.

Weeds- Rollins Aquatic will be starting around April 1st for first algae bloom. Temperature has to be 50 degrees for product to work. Muck control will be in May, has to be 60 degrees. Information will be available on GLA website. Boats- Dave Barker asked anyone purchasing a boat to please have it measured before they buy it.

Shoreline-He also spoke of the starting of the Coal city road project. There was a lengthy discussion of allowing McCoy marine to build a floating for a residence that can not accommodate the dock being built on sight. It was asked that McCoy marine built it at the marina for a 500 fee or if he could built it at his personal residence and float it over. He will provide additional insurance and also get approval from his neighbors to do so. Dave Baker made a motion seconded by Jim Grady to approve permits for 2 floating docks to be built at George McCoy's residence and floated to final destination, and that any future requests for that type of service will be based on a case by case evaluation. Vote unanimous motion carried.
